TASMANIAN CANINE ASSOCIATION INCORPORATED

RULES FOR THE ELECTION OF COUNCILLORS

1. Those members eligible to vote at an election for councillors shall have been a financial member of the Tasmanian Canine Association Inc for a continuous period of not less than six (6) months at 31 December 2018.
2. A member under the age of eighteen (18) years is **not** eligible to vote at an election for councillors.
3. Only those members resident in the state of Tasmania shall be eligible to vote at an election for councillors.
4. **An eligible financial member of the TCA Inc may cast a vote for up to but not more than four candidates. The four candidates who receive the highest number of votes shall be elected to the vacant positions for a three year term February 2019 to February 2022.**

In the event of a tied vote for the last position, the names of those candidates who received the identical number of votes in the tie shall be subject to a simple draw, and the winner of the draw shall be duly declared elected as a Councillor.

5. A ballot paper shall be sent to eligible members and shall be completed and received by the Returning Officer, Locked Bag 1, North Hobart TAS 7002, not later than **4 pm FRIDAY 28 DECEMBER 2018**. Any ballot papers received by the Returning Officer, subsequent to that date and time, shall be retained unopened by the Returning Officer.
6. A ballot paper received from a member, whose status of membership does not comply with (1) above, shall be retained unopened by the Returning Officer.

TCA PRESIDENT'S REPORT

We are rapidly approaching the end of another year. Where has it gone? Dogs Tasmania last year promised members three things. The first was an immediate review of the election procedures in the Constitution. This was completed in late 2017 following wide consultation with members and was instituted for the election at the end of 2017.

We promised a review of all facets of the office management. This was completed earlier this year and the report was made available to members. I am pleased to say that all recommendations in the report accepted by the Board have now been implemented. The one recommendation not accepted, was the provision of I Pads to Councillors to enable meetings to be less paper orientated. The Council did not accept this recommendation as it felt it could not justify the expense.

The final item was the complete review of the Constitution. This has commenced but is progressing less speedily than was hoped. When the draft is completed it will be circulated for members' comments before any further action is taken.

Another big issue has been the provision of grounds in both the north and south. Congratulations to the Quercus Park Clubs for the great work they have done.

In the south, progress has not been good. The most recent prospect which appeared promising will not be a goer as the Greyhound Assistance Program has purchased existing kennels and will not be going ahead with their project. We still haven't been advised of a finishing date for the Dog Area at the Showground but would anticipate it will be in the near future. After this is advised we will call a meeting of Southern Clubs and Members to see what steps we should take. The ground floor of the grandstand and the lawned area in front of it will be available for our use.

Our hobby could not continue without the sterling efforts of volunteers. However we are all getting older and the pool is getting more thinly spread. Even if you don't wish to be on a Club Committee, all Clubs will gladly accept volunteers especially for show day activities. If you don't already, put a little bit back into the sport and see if you can help one of our many clubs.

Nominations have closed for the next election and as there are 5 candidates an election will be required. All details are in this gazette, so please lodge your vote for the person/s you consider will assist the dog world to go forward.

I attended the recent ANKC Conference and a number of decisions were made which may be of interest to members. A summary of the major decision is in this gazette. In addition a decision whether or not to change the British Bulldog standard was deferred as was the decision to recognise the Australian Bosdog.

Unfortunately, the Council is still receiving reports of unsportsmanlike behaviour of exhibitors at shows. There is a big difference between a reasonable discussion and some of the behaviour being reported. It's not that difficult to be respectful and tone down some of the language, so could members have a go at it.

We are in the festive season, so on behalf of all Councillors and the Management and staff, can I wish you all the compliments of the season and hope that 2019 is a great year for everyone.

FROM THE OFFICE



The TCA Inc office closes at 12 noon Wednesday 19 December 2018 for the Christmas break and will reopen at 10 am Monday 7 January 2019. On behalf of Judy, Debbie and myself I wish everyone a safe and happy Christmas and 2019.

When driving their vehicles at TCA Inc sanctioned fixtures members are requested to keep their speed to a minimum to avoid potential accidents.

Members are reminded that the TCA Inc offers a state-wide microchipping service at a cost of \$20 per microchip including registration on a nation-wide database for life. Please contact the office for further information.

Exhibitors are reminded of TCA Inc Regulation 129.3, hereunder stated:

Baiting and feeding of dogs in the conformation judging ring will be permitted. However a Judge has the right to prohibit baiting. Dropping or throwing of bait is not permitted. When a Ring Steward becomes aware or is advised that an exhibitor is dropping/throwing bait the Steward must first warn the offender and request that they pick up the bait. If the exhibitor continues to throw/drop bait the Ring Steward shall be empowered to suspend judging and order the removal of the exhibitor and exhibit from the judging ring. An Affiliate may impose a penalty not exceeding 2 units (as per the current 'Scale of Charges') for breaches of this Regulation.

Membership Suspensions:

Mr Adam Booth, Membership No 7005530060 – Due to a third breach of TCA Inc Regulation 58.1.1, hereunder stated:

The pedigree/registration document must be supplied to the purchaser within twenty eight (28) days from the date of sale or from the issue date shown on the pedigree/registration document issued by the TCA Inc, whichever date occurs first.

the three month suspension of membership that had been placed on Mr Booth for a previous breach of the same regulation that had been wholly suspended was implemented, effective from 17 October 2018 until 17 January 2019.

Miss Natalie Baxter, Membership No 7100005660 – Due to a breach of TCA Inc Regulation 58.5, hereunder stated:

No member shall make any misrepresentations in any paperwork or in relation to any matter submitted to the TCA Inc, including on TCA Inc forms. By the submission of any forms or paperwork for processing all members declare that the signatures on them are all of the persons so named and that all information is true and correct to the best of their knowledge.

Miss Baxter's membership has been suspended for a 10 year period, effective 17 October 2018 until 16 October 2028.

Exhibitors are reminded that children should be under the supervision of an adult at all times.

SHOW AND TRIAL REGULATIONS

All exhibitions conducted by the Tasmanian Canine Association Inc and its affiliates are conducted under the rules and regulations of the Association, a copy of which may be inspected at the office of the secretary of the exhibition on the day of such exhibition.

The following rules/regulations apply to all exhibitions:

Financial Members:

A person 18 years of age and over and who is a resident of Tasmania may not exhibit, handle, officiate in the judging ring or register an animal unless he/she is a current financial member of the TCA Inc. A person seven years and under the age of eighteen years who handles a dog in the judging ring is required to be a junior member of the TCA Inc or a member of an affiliated club. At least one parent or guardian is required to be a financial member of the TCA Inc.

Entry fees must accompany the entry form and should be paid by cheque or money order (refer Australia Post regulation).

Substitute Judges:

The affiliate conducting an exhibition reserves the right to substitute judges if the committee deems it necessary. Entry fees are not refundable – refer TCA Inc Regulation 227.

It is the exhibitor's responsibility to have his/her exhibit/s available for judging in all classes or events for which it is correctly entered and for the classes for which it subsequently becomes eligible – TCA Inc Regulation 33.

CODE OF BEHAVIOUR AND ETHICS

PART 1 - BEHAVIOUR

1. A member of the Tasmanian Canine Association (TCA Inc) at all times –
 - a. shall conduct themselves politely and with integrity at any TCA Inc approved event; and
 - b. shall conduct themselves in a sportsmanlike manner at such events and in any related activities or communications; and
 - c. shall respect the reputations of other members, all judges and officials, at TCA Inc approved events and in dealings in wider forums, including chat lists, on the internet and in other communications; and
 - d. shall not engage in any behaviour that is contrary to the standards accepted by the community
 - e. shall display good sportsmanship and conduct at all times so as to reflect credit upon themselves, the Australian National Kennel Club (ANKC Ltd) and the TCA Inc.

PART 2 - COMPLIANCE WITH CODE OF ETHICS

2. (1) Each person, upon signing an application for membership or renewal of membership of the TCA Inc, and being duly elected to general membership of the TCA Inc, in addition to agreeing to be bound by the Constitution, and Regulations of the TCA Inc, shall also agree to be bound by the TCA Inc's Code of Behaviour and Ethics.
(2) Any failure to comply with this Code of Behaviour and Ethics will lead to disciplinary action which may result in loss or suspension of membership or other penalty.

PART 3 - CODE OF ETHICS BREEDING AND UNDERTAKING

3. A member shall not knowingly or recklessly misrepresent the ANKC Ltd or the TCA Inc, trading as Dogs Tasmania.
4. A member shall constantly strive to improve their knowledge of their chosen breed or breeds, and their knowledge of the requirements for the care, welfare and betterment of dogs.
5. (1) A member shall ensure that all dogs under their control are properly controlled, housed, fed, watered, exercised at all times and receive veterinary care as required in accordance with any Government Regulations.
(2) All dogs shall be able to stand up to full height and be able to turn around with ease in any crate in which it is confined.
(3) A member shall ensure that dogs under their control are not left in any situation that may cause injury or death to the dog.
6. A member who leaves his or her dog in the care of another person remains ultimately responsible for that dog.
7. A member shall take all appropriate lawful measures to assist a dog in distress.
8. A member shall positively enhance the reputation of dog breeders and owners by ensuring that dogs owned by the member are not a danger or nuisance to the community.
9. A member shall not participate in, nor support, any activity that involves cruelty or damage to animals, other than a legal hunting activity.
10. A member shall not dispose of any dog owned or bred by the member to a pound or animal refuge.
11. A member shall breed primarily for the purpose of improving the quality, health, welfare, soundness or working ability of the breed in accordance with the breed standard, and not specifically for the pet or commercial market.
12. A member shall not mate a bitch before it is 12 months of age unless the bitch is of a breed that has Litter Registration Limitations regarding age as set out in Part 6 of the ANKC Regulations.
13. Except in extenuating circumstances, a member shall not cause or allow a bitch to whelp more than twice in 18 months without the prior approval of the TCA Inc.
14. Except in extenuating circumstances, a member shall not cause or allow a bitch to whelp more than six times without –
 - (a) prior veterinary certification of fitness for further breeding; and
 - (b) prior approval of TCA Inc.

15. (1) A member shall not, without the prior approval of TCA Inc, permit any of that member's pure bred dogs to be mated to –
 - (a) a dog of a different breed; or
 - (b) a cross bred dog; or
 - (c) an unregistered dog of the same breed; or
 - (d) a dog that is not on the Main Register.
 - (2) A member shall only be allowed to breed ANKC Ltd recognized pedigree dogs unless the breed concerned is on the ANKC development register and with the prior approval of TCA Inc. Special dispensation may be given for members who breed dogs on the Sporting Register upon application to the TCA Inc Council.
 16. A member shall take all reasonable action to reduce the incidence of hereditary diseases in accordance with the ANKC Ltd Code of Practice for Hereditary Diseases.
 17. A member shall not sell or otherwise transfer from his or her care any puppy under eight [8] weeks of age.
 18. A member shall not export a puppy under eleven [11] weeks of age, or any greater age as may be specified under the livestock import requirements of the country to which the puppy is being exported.
 19. (1) A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the use of dogs for the meat trade without first satisfying the TCA Inc that the purchaser is a member of an ANKC Ltd recognised canine controlling body in the overseas country.
 - (2) The member and purchaser shall further acknowledge in writing to the TCA Inc that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.
 20. A member shall ensure that any person acquiring a dog from that member understands the requirements for the care, welfare and responsible ownership of the dog, and that the person acquiring the dog has the time and facilities (e.g. adequate fences, sufficient room and proper shelter) to fulfil their responsibilities.
 21. A breeder shall maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.
 22. (1). A member shall register all puppies bred (excluding those breeds listed in ANKC Ltd Regulation Part 6, Section 6.2 whose specific colours precludes them from being registered on any Register) by that member that are living at the date of registration.
 - (2) Such registration shall include all puppies from the litter on the one litter registration application form and shall be applied for within eighteen [18] months of the date of whelping.
 23. A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of –
 - (a) the breed characteristics; and
 - (b) vaccination record or requirements; and
 - (c) responsible dog ownership information; and
 - (d) all documentation required by Dogs Tasmania.
 24. A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.
 25. (1) A member shall ensure that all dogs sold or disposed of by that member are in the best possible state of health.
 - (2) Where a dog with a health issue or disability is disposed of the member shall obtain from the recipient written and signed acknowledgement of the condition of the dog.
 26. A member shall not –
 - (a) sell or dispose of a dog to a commercial pet wholesaler or retail pet shop unless they are accredited by the Pet Industry Association of Australia Limited (PIAA); or
 - (b) allow a dog owned by that member to be given as a prize or donation or to be auctioned.
 27. A member shall not conduct nor permit mother/son, father/daughter or brother/sister matings.
- NOTE: The TCA Inc will not register the progeny of father/daughter, mother/son, brother/sister

matings on the Main Register except where ANKC Ltd Regulations Part 6 Register and Registrations Section 8, Breeding applies.

28. A member who provides or makes available a dog for use in a film, advertisement, promotion, or any media or public display shall ensure that –
 - (a) the dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and
 - (b) the dog is presented in a manner that is unlikely to create a negative impression of dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.
29. A member shall not indulge in false or misleading advertising relating to the conformation, characteristics or performance of that member's dog.
30. A member shall not misrepresent nor malign the conformation, characteristics or performance of another member's dog.



TASMANIAN CONTEST OF CHAMPIONS REGULATIONS effective 1 January 2008

1. This competition is organised by the Combined Breeds Dog Club of Tasmania Inc.
2. Any dog/bitch must have attained the title of Australian Champion by 31 December each year that is confirmed by the TCA Inc office prior to 15 January in the following year.
3. Each year the number of judges to be appointed shall be determined by the committee of the Combined Breeds Dog Club of Tasmania Inc.
4. The judges will be selected by the committee of the Combined Breeds Dog Club of Tasmania Inc and will be utilised the next day to officiate at an All Breeds Championship Show. The winner of the Contest of Champions will be excluded from exhibiting at this fixture.
5. For dogs/bitches to compete at the Contest of Champions all qualifying points must be obtained at Tasmanian shows.
6. Dogs/bitches must gain their wins in Tasmania but do not have to be owned outright by a resident of Tasmania. Dogs/bitches, at the time of qualifying, wholly owned by a person/s not resident in Tasmania are ineligible.
7. There will be 32 invitations issued to the top qualifying dogs on the following basis:
 - The top four dogs/bitches in each Group will be invited to compete.
 - The other four invitations will be determined by a wild card draw. Scoring for these positions will be as follows:
 - Best in Group – 5 points and for every multiple of 25 exhibits over 50 another point is allocated.
 - Runner Up Best in Group – half the number of points allocated to the Best in Group.
 - If any dog/bitch invited cancels, withdraws or does not accept the invitation an invitation will be issued to the next highest scoring exhibit.
8. Invitations will be forwarded to exhibitors as soon as possible but no later than 15 January in each year.
9. Judging will be by means of a knock out competition, 16 heats with the winner of each heat going through to the next round until two only remain. There will be one final winner. The order of judging will be determined by a public draw at the event prior to the commencement of judging.
10. The TCA Inc Council will appoint an independent adjudicator for the event.
11. In the event of any contingency arising which is not covered by these Regulations the club's committee, in conjunction with the TCA Inc appointed adjudicator, has the power to make such rulings as they determine are in the best interests of the club and the continuing prestige of the event.

REGULATION CHANGES EFFECTIVE 1 JANUARY 2019

Regulation 22B

An entry for an official exhibition may not be accepted unless it includes the TCA Inc membership number of the owner of the exhibit or the membership number issued by the relevant controlling body for an exhibitor not normally resident in Tasmania. The exhibitor or his agent entering a dog must complete and sign the entry form in ink, giving all details required for publication in the catalogue. The exhibitor or his agent shall be responsible for the correctness of the particulars on the entry form and shall be liable for the fees payable. An entry submitted on-line may be accepted by a club, however the Exhibitor's Declaration must be acknowledged by the person entering a dog on-line as a condition of the entry being processed. Clubs must provide exhibitors with the option of entering Conformation Shows via a recognised online entry facility ie Show Manager, Ozentries etc as well as paper entries.

Regulation 174A

Only judges who are licenced in at least four (4) Championship groups are eligible to judge Sweepstakes classes at an All Breeds Championship Show.

174B Notwithstanding, clause 174A, where All Breeds Sweepstakes are scheduled at a Show or Parade they may be judged by a judge who is licensed in at least two (2) Championship groups provided the judge is a trainee in good standing in the current Conformation Judges Training Scheme. Provided these Sweepstakes are finalised before the General Classes at the Show commence, these judges may exhibit in General Classes at the exhibition.

174C Trainee judges judging Group Sweepstakes organised by the TCA Inc Judges Training Committee are exempt from Regulation 174A and 174B but must have a Parade/Open Show Licence for the Group they are judging.

Regulation 198

At a Retrieving Trial a competent Gun Steward shall act on behalf of a person who is not legally allowed to use a gun. A person who is incapacitated for not more than three (3) months may have a competent Gun Steward act on their behalf but it must be requested on or with their entry form.

A person who is permanently incapacitated and does not hold a gun licence must apply to the TCA Inc for an exemption, and such exemption shall be noted on the entry form and produced at check-in. A person who has officially applied to Fire Arms Tasmania for a gun licence may have a competent Gun Steward to act on their behalf until they attend an approved Firearms Course. The person must apply to TCA Inc with proof of their application to Firearms Tasmania for exemption and such exemption must be noted on their entry form and produced at check-in.

Regulation 200C

Regulation 200C Field Trials that rely on the availability of game may be added to the Calendar of Events three (3) months prior to the event.

At the recent Annual General Meeting of the Australian National Kennel Council Limited held in Melbourne:

1. Election of ANKC Ltd Executive

- Mr Hugh Gent OAM was re-elected unopposed as President for a three-year term from 13 October 2018;
- Mr Brian Parker was re-elected as Vice President for a one-year term from 13 October 2018; and
- Mr David Sales was re-elected unopposed as Treasurer for a one-year term from 13 October 2018.
- Ms Pamela Campbell was elected as a member of the Executive Committee for a one-year term from 13 October 2018.

At the October 2018 ANKC Ltd Board meeting, Directors resolved/considered the following:

1. Overseas Judges Evaluation Procedure

It was resolved the ANKC Overseas Judges Evaluation Procedure be discontinued immediately.

2. CACIB Shows

It was resolved the following confirmed expressions of interest to conduct CACIB Shows in 2019-2020 have been approved by ANKC for submission to FCI for their approval:

3. Whole Body Barometric Plethysmography Chamber

The BOAS Chamber is now located at Vineyard Veterinary Hospital where testing of dogs will commence in mid-November 2018.

4. Kangal Shepherd Dog / Anatolian Shepherd Dog

It was resolved to retain both breeds with Kangal Shepherd Dogs to use the current FCI standard and the Anatolian Shepherd Dogs to use the Kennel Club (UK) standard. Anatolian Shepherd Dogs which meet the requirements of the Kangal Shepherd Dog have until 31 December 2018 to transfer to the Kangal Shepherd Dog register.

A Press Release will be issued in due course.

5. Peruvian Hairless Dog – Group Change

It was resolved that effective from 1 January 2019 the Peruvåan Hairless Dog be moved from Group 4 (Hounds) to Group 7 (Non-Sporting).

6. Bull Terrier & Bull Terrier (Miniature)

It was resolved the Bull Terrier Miniature breeders of Australia be allowed to continue to use the interbreeding program indefinitely.

7. Amendments to Breed Standards

It was resolved that ANKC will amend breed standards in January each year. The Board agreed this will benefit those preparing Theory Examinations and sitting for Theory Examinations.

Note: ANKC Ltd does not own a majority of the breed standards, so we are not able to make a change to a standard. Only the country or organisation that owns a standard may make changes and if they do so, then once they notify ANKC Ltd, those changes will now be made annually in January.]

8. **Aggressive Dog Regulations**

It was resolved that declared aggressive dogs may not be used in breeding programs and a regulation will be drafted to reflect this to come into force in 2019.

9. ***ANKC Ltd Judges' Contract**

It was resolved the existing Judges' Contract will be amended to make it generic for use by both Conformation and Sporting Judges.

10. ***Overseas Judges Application Form – Amendment**

It was resolved the declaration on the Overseas Judges Application Form be amended to read as follows:

"I also declare I am physically fit and capable of judging in the normally accepted manner.

I acknowledge this is a continuing obligation and I undertake to notify the club should my health status impact upon my ability to judge in the normally accepted manner."

11. ***ANKC Ltd Regulations Part 6 – The Register & Registration – Amendment**

It was resolved that Regulations Part 6 – The Register & Registrations, Section 10 Recognition of New Breeds, be removed in its entirety effective from 1 January 2019.

12. *** National Judges Code of Practice and Conduct – Amendment**

It was resolved that Clause 4 of the National Judges Code of Practice and Conduct to be amended to read:

4. A Judge shall present himself/herself in attire that is acceptable, appropriate and comfortable for each judging assignment. Footwear appropriate to the discipline shall be worn.
