TCA PRESIDENT'S REPORT

Well we finally have received notice from the RAS that Spotlight will take possession of the area they are building on at the Showgrounds tentatively from 1 October. This of course will include the kennel section. RAS needs to clear the site prior to that date. It appears that all shows until the end of August will be okay. The Judges Training exams hopefully will be able to be held where they usually are, indoors and the Golden Retriever Club may have to move to Brighton but this has not been confirmed as yet. After that there are no shows scheduled for the Showgrounds during 2019. The office has booked all dates for 2020 and 2021 at Brighton. Members will be kept up to date with proceedings.

I've mentioned before the perilous state of some clubs' committees. We desperately need new blood. If you have thought about joining a Club please do so. Even if you can only help on the day of the show, you will be welcomed with open arms. We've already had two clubs reducing the shows they will run because of lack of womanpower. If it keeps going like this you will be lucky to have shows to go to.

On a brighter note, it was great to see the entries in Sweepstakes at both the Working and Hobart Dog Clubs shows. This is a real help to our trainee judges.

Hobart and Launceston Royals' entries close in September. Unlike other shows, the entries are not held over until the last minute, so get your entries in. Also note the many associated shows that will be held on these weekends.

ANKC has decided to update its IT software/hardware. This means that the compulsory introduction of DNA proved parentage scheduled to begin on 1 January 2020 has been deferred. TCA is in favour of DNA testing and will consider it in the future and whether we should go it alone in the meantime like Queensland has done.

A Special Directors Meeting of ANKC will take place in late July to firm up progress on the upgrade.

Notice is out for the Annual Meeting of ANKC in October. Any notices of motion have to be submitted by early August. No doubt issues such as the Bosdog recognition and the Bulldog standard will again be on the agenda.

Finally a number of members have contacted me regarding a recent social media reference to Quercus Park as the State Canine Centre and questioning whether we will be moving all of our activities there because of the loss of the Showground.

Quercus Park canine area is administered by an incorporated association whose members are most of the affiliates in the north. The Association itself is not a TCA affiliate but hires the ground to our affiliates. While it is a great facility, TCA has no intention of consolidating all of its operations there.

I drove home from the north west recently and the trip was appalling in the fog. With all the roadworks please drive safely.

2019–20 CONFORMATION JUDGES TRAINING SCHEME

Members who wish to join the Conformation Judges Training Scheme are advised that applications to join the scheme must be submitted **not later than 20 September 2019**. Dogs Tasmania may consider an application from a person transferring from another State or Territory of Australia or overseas, who can provide evidence of their eligibility. LATE APPLICATIONS WILL NOT BE CONSIDERED.

LABRADOR RETRIEVER BREEDERS/OWNERS

In accordance with Regulations Part 6 – The Register & Registrations Clause 8.17 an online survey is now available from the link provided below where ANKC is seeking feedback as to whether a Litter Registration Limitation is to be applied to litters mated on or after 1 June 2020 where the minimum breeding age for Labrador bitches is 18 months at the time of mating (unless a veterinary certificate is produced stating that for health reasons the bitch should be mated before 18 months).

If litter registration limitations are approved for the Minimum Breeding Age for Labrador Retriever bitches, breeders of litters whelped on or after 1 June 2020, will be required to comply with the requirements as a prerequisite to registration of any litter on the ANKC Ltd Main Register. Litters which do not meet the above requirements will only be able to be placed on the Limited Register and will be flagged not to be upgraded.

A majority of registered owners within the breed and responding to this survey must be in favour before approval is given by the ANKC Ltd.

The TCA Inc offers a microchipping service throughout the state at a cost of \$20 per dog/puppy (including lifetime registration on a nation-wide data base).

PROCEDURE TO LODGE A COMPLAINT

TCA Inc Regulation 96, hereunder stated, sets out the procedure that must be followed for a complaint to be lodged:

96 A complaint may be lodged against any member of the TCA Inc for breaches of these Regulations and its Code of Ethics, by members of the TCA Inc or another Controlling Body or a member of the general public as follows:–

In respect of an alleged breach which occurs at a sanctioned event the complainant must either:

- 1 Lodge the complaint in writing with the Event Manager on the day of the event including all details of the alleged breach, names and addresses of witnesses and any other supporting documentation.
- 2 If the complaint is lodged on the day with the Event Manager it must be accompanied by a fee of 1 penalty unit on the day and 4 penalty units must be paid to the TCA Inc Office within seven (7) days (if the complainant does not forward the 4 penalty units within seven (7) days then the 1 penalty unit will be forfeited).
- 3 Or if the complaint is not lodged on the day of the fixture it must be in writing and received at the TCA Inc Office within seven (7) days of the alleged breach and accompanied by a fee of 5 penalty units.
- 4 When a complaint is lodged by a Club Official, Judge, Steward in the course of their official duties or Non-Member of the TCA Inc or another Member Body a fee is not required.
- 5 In respect of an alleged breach which does not occur at a sanctioned event the complainant must:–
Lodge the complaint in writing to the office of the TCA Inc within seven (7) days of the alleged breach, names and addresses of witnesses and any supporting documentation; The complaint must be accompanied by a fee of 5 penalty units.
- 6 On receipt of a complaint the person/s against whom the complaint has been laid must be advised in writing of the nature of the complaint within fourteen (14) days by the Executive Officer.
- 7 Where a valid complaint is lodged under this Regulation, a member of the Association's Investigations Panel shall investigate the complaint and determine the complaint in accordance with the Constitution and Regulations of the TCA Inc. A copy of the complaint will be sent to the member against who the complaint has been made to enable them to provide a response to the allegations. No complaint will be investigated unless the appropriate fee is paid.
- 8 The fee paid to lodge the complaint will be refunded to the complainant only if the complaint is upheld.

To lodge a complaint relating to a matter that has occurred at a TCA Inc sanctioned event the complainant has three options open to them to lodge their complaint:

- i) Lodge the complaint with the Event Manager together with one \$10.00 partial payment of the lodgement deposit. The \$40.00 balance must be paid within 7 days for the complaint to proceed or
- ii) Lodge the complaint, in writing, within 7 days of the alleged breach of TCA Inc Regulations with the TCA Inc office accompanied by the \$50.00 lodgement deposit.

At the June 2019 ANKC Ltd Special Board Meeting, directors resolved/considered the following:

1. * ANKC Ltd Regulations Part 6 – The Register & Registration: Amendment to Clause 3.2

It was RESOLVED that ANKC Ltd Regulations Part 6 The Register & Registration, Clause 3.2 be amended by the inclusion of the following paragraph after Clause 3.2(e):

“All documentation submitted with an application for re-registration of an imported dog and/or semen must be in English or accompanied by an official document translated in English by an authorised interpretation/translation service, e.g., an Australian or State Based Interpreting Service.”

2. * ANKC Ltd Regulations Part 6 – The Register & Registration: Removal of Clause 6.3

It was RESOLVED that ANKC Ltd Regulations Part 6 – The Register & Registration Clause 6.3 – Fertilised Ova (as noted below) be removed from the regulations.

“6.3 Fertilised Ova (10/02)

6.3.1 *Litters produced using fertilised ova are to be registered using the standard Member Body litter registration form and must be accompanied by a declaration by the breeder identifying the donor dam, the semen donor dog, and the surrogate bitch.*

6.3.2 *The surrogate bitch must be registered in the breeder’s name unless a valid legal contract or special application provides otherwise.*

6.3.3 *Breeders are to maintain records relating to the collection, fertilisation, implantation and ownership of ova.*

6.3.4 *Breeders are advised to record a DNA profile, or store a sample of tissue, blood or saliva, for the donor bitch, the semen donor dog, and the surrogate bitch.*

6.3.5 *The registration of a dog from fertilised ova will have the letters FO in brackets after the name. Where the fertilised ova was imported and then implanted, the letters Imp and the country abbreviation in brackets will be added.”*

3. * ANKC Ltd Regulations Part 6 – The Register & Registration: Removal of Clause 6.13

It was RESOLVED that ANKC rescind in its entirety effective immediately Regulations Part 6 – The Register & Registration, Section 6, Clause 6.13 – Parentage Proven for Registration.

“6.13 Parentage Proven for Registration (Added 06/18, 5.1)

6.13.1 *All puppies whelped after 01 January 2020 and being registered on the ANKC Ltd database as Main Registered are to be Parentage Proven by DNA. All results are to use the International Society for Animal Genetic (ISAG) marker and are to be submitted to the member body prior to registration.*

6.13.2 *Where a breeder makes application to upgrade a dog to the Main Register then the dog is to be Parentage Proven as per 6.12.1 prior to being upgraded.*

6.13.3 *Collection and testing of the DNA sample is to be conducted pursuant to protocols at Section 2 of these Regulations.*

6.13.4 *All dogs, frozen semen and Fertilised Ova imported into Australia from 1 January 2020 are to be Parentage Proven in accordance with this section.*

6.13.5 *All Frozen semen registered after 1 January 2020 is to be Parentage Proven in accordance with this section.”*

4. * ANKC Ltd Regulations Part 6 – The Register & Registration: Removal of Clause 8.8.2

It was RESOLVED to remove the Litter Registration Limitation relative to the requirement for Haemophilia testing as a prerequisite for German Shepherd Dogs to participate in the German Shepherd Dog Council (Australia) Breed Survey scheme effective from 1 January 2020.

5. * ANKC Ltd Trick Dog Rules

It was RESOLVED that ANKC endorse the recognition of Trick Dog Rules to be implemented from 1 January 2020.

Responding to Activists

STEPS FOR HANDLING CONFRONTATION AT AN EXHIBITION OR EVENT

Proudly show our practices are best practice	Regardless of the risk of confrontation, every exhibitor should proudly uphold the standards expected of us as loving dog owners and members of Dogs Tasmania and present our dogs and ourselves positively.
Advise the show or trial manager, call 000 if needed	Advise the event manager if you believe activists are present and they will advise the local police. If activists create a disruption or confrontation. call 000 immediately. If you call 000 clearly articulate the risk that the activists are posing: to yourself and others, the dogs' welfare, personal and venue property, etc.
Do not engage	Do not engage directly. Keep calm even if provoked and keep your distance if possible.
Ask them to leave	If activists enter the area you are using to house your dogs, speak with them politely to ask them to leave. Acknowledge their right to state their opinions in a lawful manner but ask that they respect your right to continue to look after your dogs' welfare in a safe manner without distress. Ask them to please leave the area and move to a space away from the dogs. They may not respond to the request, but it will make it clear they do not have permission to be there. Do not engage with them further.
Move yourself and your dogs to a safer position	Your safety and welfare and that of your dogs comes first. If activists won't leave, relocate to an area that is safer for you and your dogs.
Create a record	Video footage and photos taken on your phone of the above can be used by police. If there has been damage to property record the details and if possible wait until police have examined the scene before touching anything. Please always consider the safety of yourself and dogs when confronted with activists.

SHOW AND TRIAL REGULATIONS

All exhibitions conducted by the Tasmanian Canine Association Inc and its affiliates are conducted under the rules and regulations of the Association, a copy of which may be inspected at the office of the secretary of the exhibition on the day of such exhibition.

The following rules/regulations apply to all exhibitions:

Financial Members:

A person 18 years of age and over and who is a resident of Tasmania may not exhibit, handle, officiate in the judging ring or register an animal unless he/she is a current financial member of the TCA Inc. A person seven years and under the age of eighteen years who handles a dog in the judging ring is required to be a junior member of the TCA Inc or a member of an affiliated club. At least one parent or guardian is required to be a financial member of the TCA Inc.

Entry fees must accompany the entry form and should be paid by cheque or money order (refer Australia Post regulation).

Substitute Judges:

The affiliate conducting an exhibition reserves the right to substitute judges if the committee deems it necessary. Entry fees are not refundable – refer TCA Inc Regulation 227.
