As our first show dog, we had a lot to learn together. His supreme temperament, gorgeous movement and breed conformation was obvious when only a baby puppy, and he has received compliments and awards from many highly respected and accomplished gundog specialists and International all breeds judges. We sincerely thank all of the judges for recognising his quality and awarding him highly, and also to our fellow exhibitors that have offered their support and guidance.

Merlin is proudly owned, groomed and presented by Benjamin Evans, and co-handled by B. Evans and A. Busoli.

In just over three months since finishing baby puppy class with four in group wins from four entries, Merlin has accomplished a lot for a 9.5 month old puppy against some experienced and respected competition in our very strong gundog group.

Merlin has a fantastic career ahead of him, he absolutely loves the show ring and has a lot of maturing to do. We are excited to see what the future holds! He is currently the only Flat Coated Retriever being exhibited in Tasmania, and one of only a handful actively showing in Australia. It is exciting to be involved with a beautiful, rare gundog breed and to see him being awarded so highly as a young puppy.

A huge thank you to Helen & Peter Eley at Kellick for breeding and rearing such a magnificent Flatie and trusting us. We hope you are equally as proud as us with his results so far. Special thanks to Christine and Bob Clarke for your Flat Coat grooming and handling lessons, we are so very grateful for your expertise and for welcoming us to the breed so warmly. The Flat Coated Retriever community in Australia has been very supportive of our endeavours with Merlin and we are proud breed ambassadors.

PRESIDENT'S REPORT

FOR ANNUAL GENERAL MEETING OF MEMBERS

WEDNESDAY 8 MARCH 2021

It is a pleasure to be able to present this report to members.

2020 has been a year like we have never experienced before. We are indeed fortunate that we live in Australia and have escaped most of the devastation which has rocked the rest of the world. Although our sport was shut down for four months and has slowly picked up, the long term damage has been minimal. Most of our major shows were cancelled and we are still battling with non-arriving judges but with the commencement of the vaccination program perhaps we are through the worst.

Financially because of the government's Job Keeper program we have finished the year well financially. However, we are now no longer eligible for that program and our revenues are likely to be down in 2021 so there is every chance we will need this buffer to maintain our financial sustainability.

We have released our draft Constitution twice to the membership for consultation. Unfortunately, several new issues have arisen and the working party will be reviewing those in the near future, with a view to a Special General Meeting later in the year. The Regulations review has stalled and Council will need to consider how we might progress this task.

The move to Pontville has been fairly smooth and we are looking forward to the erection of the adjacent building which will give us an office as well as wet weather shelter. Quercus has continued to be embellished with indoor exhibiting facilities not far away.

The Conformation Judges Training Scheme was able to be maintained with the exams moved to November which in fact was far more suitable weatherwise. Because of the lockdown 100% local assessors were used and five of the seven trainees were successful giving us also two new all breeds judges. Other disciplines also had new judges approved. Congratulations to all.

A number of new disciplines have been approved by ANKC giving members a wider range of activities to be involved in.

I was reappointed Treasurer of ANKC in October which gives Tasmania a voice on the national body. The major activities at the present is new integrated business system. We are presently having contracts examined by our lawyers and it should get under way during the second quarter of 2021. The cost is likely to be about \$500,000. We are also looking to commencing a publicity campaign to reposition ANKC to combat the threat of the MDBA and broaden the appeal to the general public. Look forward to a launch soon.

You will all be aware of the legislation interstate which is limiting dog owners' rights. ANKC is very aware of the need to fight against these unjust changes. At the local level we keep abreast of what is happening in the bigger world. Meetings were held with the RSPCA, the Labor Party and the Department of Primary Industry in December to ensure we are aware of what is happening.

I should also like to thank our team of volunteers, who are the unsung heroes of our organisation. Without them there would be no organisation.

In conclusion I would like to thank all Councillors for the work they too have put in during the year and the great support they have given me. I would also on behalf of members thank Geoff Blyth for the efforts he has put in while on Council not just in this stint but over many years previously and welcome Teena Sloan and Marie Aitchison to Council.

It would also be remiss not to acknowledge the sterling efforts of Kerry, Judy and Debbie during 2020. The pandemic has caused a lot of additional work while reducing income. The result is a credit to them.

STEWARD UPGRADE:

Mr C Cocker (phone 0400 064 972) has been upgraded to a Ring Steward.

Exhibitors are reminded that they must wear footwear that is suitable for the ring conditions on the day.

Clubs are reminded that they must have 'pooper scoopers', available at ringside, not just plastic bags.

Memberships paid via direct deposit or telephone cannot be updated until the signed membership form is received by the office.

USING A RUNNER

Members' attention is drawn the amended Regulation 129.2, hereunder stated:

If a member is, or becomes incapacitated on the day of the show and requires an assistant to handle their dog, the Ring Steward must be advised prior to the exhibit entering the judging ring. The assistant must not under any circumstances impede the Judging.

Summary of the ANKC Ltd Special Board Meeting

Held via Zoom Video Conferencing on 13 February, 2021

At the February 2021 ANKC Ltd Special Board meeting, Directors resolved/considered the following:

1. * ANKC Ltd Regulations Part 6 – The Register & Registration

It was RESOLVED that Regulations Part 6 – The Register & Registration, Section 3-Imported Dogs, Clause 3.2 be amended to read:

- 3.2 All pedigree dogs that are imported into Australia except those imported from New Zealand (including dogs whelped in Australia and previously exported from Australia) to be re-registered with ANKC Ltd must provide, at the time of registering the dog the following:
- a. Proof of identification, i.e. microchip or tattoo
 - b. Proof of Importation, such as a "health permit", "export permit" or "import permit"
 - c. An original Export Pedigree and Ownership Certificate (if two separate documents) indicating the Australian member's name and current residential address showing all registration numbers, titles granted and colours by the overseas body. The Export pedigree must be at least first and second generations complete and the 3rd generation a maximum of 4 names missing.
 - d. Proof of Shipment from the country of origin to Australia such as transportation documents "Airway Bill" OR an Authorised Agency under the Bio Security Act 2016, Bio Security Release form (b and c above are not required if you have the DAWR release)
 - e. Delete

Note: This amendment to the regulations will be effective 1 July 2021.

2. * ANKC Ltd Regulations Part 6 – The Register & Registration

It was RESOLVED that Regulations Part 6 – The Register & Registration, Section 6 be amended to read:

- 6.3.4.8 Effective from 1st January 2017 French Bulldog: Merle Solid Black, Black & White, Black and Tan, Mouse, Grey/Blue, Liver/Chocolate, or French Bulldogs showing marked variation from those colours listed in the Breed Standard and all patterns of these colours (including those registered in other countries) can only be registered on the Limited Register, flagged "not to be upgraded". (Added 10/16, 9.9) (Amended 02/21)

AND

the inclusion of an additional Clause, numbered 6.3.4.9, to read as follows:-

6.3.4.9 Effective from 1 July 2021

No 'Merle' French Bulldogs can be registered on any ANKC Ltd register and a 'Merle' French Bulldog imported into Australia cannot be registered on any register. No 'Long Coat or Hairless' French Bulldogs can be registered on any ANKC Ltd register. (Added 02/21)

Note: This amendment to the regulations will be effective 1 July 2021.

3. * ANKC Ltd Regulations Part 8 – Member Bodies & Membership

It was RESOLVED that Regulations Part 8-Member Bodies & Membership, Section 2: Membership be amended by the inclusion of new Clauses, numbered 2.1, 2.2, 2.3 & 2.4, which read:-

- 2.1 A member of an ANKC Ltd Member Body must, as a minimum, be a member of the Member Body for the jurisdiction in which they reside. This membership shall be regarded as the person's Primary Membership. A member of a Member Body shall have

SUMMARY TCA INC COUNCIL MINUTES

JANUARY 2021

PRESENT: Mr D Sales (Chairman), Mesdames S Axton, T Counsell, E Job, C Lowe, Misses P Hallam, T Sloan, Messrs G Blyth, S Eastley, R Lowe, and K Smith (Executive Officer) with Mrs M Aitchison present as an observer.

D Sales welcomed T Sloan to her first 'face to face' Council meeting and Mrs M Aitchison to the meeting as an observer and advised that she would take her seat at the Special Meeting of Council to be held after the Council meeting scheduled for 24 February 2021.

APOLOGIES: Ms T Luttrell and Mr G Parry.

BUSINESS ARISING FROM THE MINUTES:

5.1 Southern Venue

The EO advised the meeting that he had contacted Brighton Council regarding the shed build and that he was still awaiting a response.

The problems of parking at ringside and tarps/gazebos being set up were discussed.

RESOLVED: 'The appointment of a Management Committee be listed as an agenda item for the next meeting of Council.'

FINANCE:

Financial Reports for the period 01 to 31 December 2020 indicating a profit of \$5250.98 for month compared to a profit of \$888.24 for the same period in 2019, a Year To Date profit of \$95478.04 compared to a profit of \$35373.47 for the same period in 2019 and Bank Register for the period 1 – 31 December 2020 indicating deposits totalling \$87236.24 and withdrawals totalling \$44013.08 for the month.

The EO advised the meeting that the Jobkeeper supplement had been lost for the period 01 January to 31 March 2021.

GENERAL BUSINESS:

Executive Officer's Report

The EO's report advised that:

- Processing was at an eight working day turnaround;
- There were 186 puppies registered in the period 25 November 2020 to 20 January 2021 compared to 265 for the same period last year, a total of 2509 for 2020 compared to 2463 in 2019;
- There were 1019 members including Life Members as at 31 December 2020 compared to 983 in 2019;
- 25 membership renewal reminders were sent out for December 2020.
- Clubs were given an exemption from TCA Inc Regulation 235 relating to sashes and trophies until 31 December 2020 and asked if this exemption was going to be extended;

RESOLVED: 'The period of exemption ended 31 December 2020.'

CODE OF BEHAVIOUR AND ETHICS

PART 1 - BEHAVIOUR

1. A member of the Tasmanian Canine Association (TCA Inc) at all times –
 - (a) shall conduct themselves politely and with integrity at any TCA Inc approved event; and
 - (b) shall conduct themselves in a sportsmanlike manner at such events and in any related activities or communications; and
 - (c) shall respect the reputations of other members, all judges and officials, at TCA Inc approved events and in dealings in wider forums, including chat lists, on the internet and in other communications; and
 - (d) shall not engage in any behaviour that is contrary to the standards accepted by the community
 - (e) shall display good sportsmanship and conduct at all times so as to reflect credit upon themselves, the Australian National Kennel Club (ANKC Ltd) and the TCA Inc.

PART 2 - COMPLIANCE WITH CODE OF ETHICS

2. (1) Each person, upon signing an application for membership or renewal of membership of the TCA Inc, and being duly elected to general membership of the TCA Inc, in addition to agreeing to be bound by the Constitution, and Regulations of the TCA Inc, shall also agree to be bound by the TCA Inc's Code of Behaviour and Ethics.
 - (2) Any failure to comply with this Code of Behaviour and Ethics will lead to disciplinary action which may result in loss or suspension of membership or other penalty.

PART 3 - CODE OF ETHICS BREEDING AND UNDERTAKING

3. A member shall not knowingly or recklessly misrepresent the ANKC Ltd or the TCA Inc, trading as Dogs Tasmania.
4. A member shall constantly strive to improve their knowledge of their chosen breed or breeds, and their knowledge of the requirements for the care, welfare and betterment of dogs.
5. (1) A member shall ensure that all dogs under their control are properly controlled, housed, fed, watered, exercised at all times and receive veterinary care as required in accordance with any Government Regulations.
 - (2) All dogs shall be able to stand up to full height and be able to turn around with ease in any crate in which it is confined.
 - (3) A member shall ensure that dogs under their control are not left in any situation that may cause injury or death to the dog.
6. A member who leaves his or her dog in the care of another person remains ultimately responsible for that dog.
7. A member shall take all appropriate lawful measures to assist a dog in distress.
8. A member shall positively enhance the reputation of dog breeders and owners by ensuring that dogs owned by the member are not a danger or nuisance to the community.
9. A member shall not participate in, nor support, any activity that involves cruelty or damage to animals, other than a legal hunting activity.
10. A member shall not dispose of any dog owned or bred by the member to a pound or animal refuge.
11. A member shall breed primarily for the purpose of improving the quality, health, welfare, soundness or working ability of the breed in accordance with the breed standard, and not specifically for the pet or commercial market.
12. A member shall not mate a bitch before it is 12 months of age unless the bitch is of a breed that has Litter Registration Limitations regarding age as set out in Part 6 of the ANKC Regulations.
13. Except in extenuating circumstances, a member shall not cause or allow a bitch to whelp more than twice in 18 months without the prior approval of the TCA Inc.

14. Except in extenuating circumstances, a member shall not cause or allow a bitch to whelp more than six times without –
 - (a) prior veterinary certification of fitness for further breeding; and
 - (b) prior approval of TCA Inc.
15. (1) A member shall not, without the prior approval of TCA Inc, permit any of that member's pure bred dogs to be mated to –
 - (a) a dog of a different breed; or
 - (b) a cross bred dog; or
 - (c) an unregistered dog of the same breed; or
 - (d) a dog that is not on the Main Register.
 - (2) A member shall only be allowed to breed ANKC Ltd recognized pedigree dogs unless the breed concerned is on the ANKC development register and with the prior approval of TCA Inc. Special dispensation may be given for members who breed dogs on the Sporting Register upon application to the TCA Inc Council.
16. A member shall take all reasonable action to reduce the incidence of hereditary diseases in accordance with the ANKC Ltd Code of Practice for Hereditary Diseases.
17. A member shall not sell or otherwise transfer from his or her care any puppy under eight [8] weeks of age.
18. A member shall not export a puppy under eleven [11] weeks of age, or any greater age as may be specified under the livestock import requirements of the country to which the puppy is being exported.
19. (1) A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the use of dogs for the meat trade without first satisfying the TCA Inc that the purchaser is a member of an ANKC Ltd recognised canine controlling body in the overseas country.
 - (2) The member and purchaser shall further acknowledge in writing to the TCA Inc that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.
20. A member shall ensure that any person acquiring a dog from that member understands the requirements for the care, welfare and responsible ownership of the dog, and that the person acquiring the dog has the time and facilities (e.g. adequate fences, sufficient room and proper shelter) to fulfil their responsibilities.
21. A breeder shall maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.
22. (1) A member shall register all puppies bred (excluding those breeds listed in ANKC Ltd Regulation Part 6, Section 6.2 whose specific colours precludes them from being registered on any Register) by that member that are living at the date of registration.
 - (2) Such registration shall include all puppies from the litter on the one litter registration application form and shall be applied for within eighteen [18] months of the date of whelping.
23. A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of –
 - (a) the breed characteristics; and
 - (b) vaccination record issued by a veterinary practice and future vaccination requirements (if applicable); and
 - (c) responsible dog ownership information; and all documentation required by DogsTasmania.
24. A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.
25. (1) A member shall ensure that all dogs sold or disposed of by that member are in the best possible state of health.

CLUB COVID-19 CHECKLIST/REQUIREMENTS FOR CONFORMATION FIXTURES

DOGS TASMANIA COVID-19 CHECKLIST

- In the last 14 days, have you travelled from overseas or a COVID-19 hotspot?
- Have you been in close contact with a person who is positive for COVID-19?
- Are you currently, or have you recently experienced a cough, fever, sore throat, fatigue, or shortness of breath?
- IF YOUR ANSWER IS YES TO ANY OF THE ABOVE PLEASE DO NOT ENTER THE GROUNDS.

All Exhibitors are asked to practice THE 1.5m social distancing requirement at all times where possible. Masks will of course be freely available for Judges and Officials if requested but there is no requirement to wear a mask.

Before judging

- Upon arrival ALL exhibitors and any additional people/guests must check in using the Tasmanian Government QR code. CLUBS please make these available around the grounds and ensure there are multiple copies at the table for exhibit number collection. A pen and paper (this must be sanitised after use) must also be available with name and phone number information collected for anyone not able to use the Tasmanian Government QR code App.; and
- The club is to ensure at least ONE committee person is available to hand out exhibit numbers – reducing any contact across envelopes and ensuring distancing is maintained;
- The club is to ensure sanitiser is available for use on the office desk;
- The club is to ensure 1.5m is observed by anyone waiting to check-in; and
- TCA Representatives' report paperwork is to include a copy of the current guidelines to ensure adherence to the safety protocol is followed; and
- Entrance and exit gates to be separate and must be strictly monitored even if handlers are changing dog.

Judging

- All Judges are to be given advice of the guidelines BEFORE judging;
- The Judge should not shake hands with any exhibitor – use the elbow bump instead;
- The Judge can go over the dog and mouth the dog. If Judges choose to mouth the dog, wipes or sanitiser must be used regularly;
- Stewards are to ensure assembly areas are kept clear with only the next few breeds in the immediate area, and
- Sanitiser must be readily available for Judges and Stewards.

General

- A plan must be submitted to the Dogs Tasmania office seven days prior to the fixture detailing how the club will comply with these requirements;
- All areas to be controlled and the current social distancing requirement enforced. Event

Managers/Club Officials can suspend activity and request people to leave the grounds or stop the fixture completely if people do not adhere to social distancing rules;

- Committee to ensure there is appropriate soap and paper towel in the toilets throughout the day;
- Any canteen facilities must observe safe food and cash handling (we recommend having one designated person responsible for the cash handling only);
- Hand sanitiser must be available for canteen patrons to use;
- Canteen workers must ensure distancing is observed, and
- Current space and capacity regulations to be observed in any indoor areas (offices, toilets, canteens). Currently the recommendation is 2m² per person.

Attending the Event

No one is to attend the event if they have COVID-19 symptoms, stay at home if you are unwell or have a cough, fever, sore throat, fatigue or shortness of breath. If you become unwell during the event locate the Show Manager and advise. When entering the grounds it is the exhibitor's responsibility to cease attendance if you become unwell. Maintaining physical distancing requirements is also the exhibitor's responsibility.

Current as at 23 March 2021 but subject to change to meet government requirements. Exhibitors need to check the Dogs Tasmania Website regularly for updates.

- (2) Where a dog with a health issue or disability is disposed of the member shall obtain from the recipient written and signed acknowledgement of the condition of the dog.
 - (3) A member shall take all reasonable action to reach agreement with a puppy purchaser if the puppy has health or behavioural problems that were not diagnosed prior to the sale of the puppy.
26. A member shall not –
 - (a) sell or dispose of a dog to a commercial pet wholesaler or retail pet shop unless they are accredited by the Pet Industry Association of Australia Limited (PIAA); or
 - (b) allow a dog owned by that member to be given as a prize or donation or to be auctioned.
 27. A member shall not conduct nor permit mother/son, father/daughter or brother/sister matings. NOTE: The TCA Inc will not register the progeny of father/daughter, mother/son, brother/sister matings on the Main Register except where ANKC Ltd Regulations Part 6 Register and Registrations Section 8, Breeding applies.
 28. A member who provides or makes available a dog for use in a film, advertisement, promotion, or any media or public display shall ensure that –
 - (a) the dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and
 - (b) the dog is presented in a manner that is unlikely to create a negative impression of dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.
 29. A member shall not indulge in false or misleading advertising relating to the conformation, characteristics or performance of that member's dog.
 30. A member shall not misrepresent nor malign the conformation, characteristics or performance of another member's dog.

- a maximum of 1 (one) Primary Membership. This will not prevent persons from joining the Member Bodies of other jurisdictions, either individually or in partnership.
- 2.2 Each Member Body shall determine what qualification/s it recognises as proof of residency.
- 2.3 A person shall only be permitted to transact all member services, ie, register and maintain a prefix, register a litter or a dog, apply for a title or participate in a Judges Training Program, or undertake an activity similar to aforementioned, in the jurisdiction in which they hold their Primary Membership as defined in 2.1, above.
- 2.4 In relation to a partnership, a least one of the partners must hold their Primary Membership in the jurisdiction where the partners are attempting to undertake an activity, as described in 2.3, above.

AND

THAT the current Clauses, numbered 2.1, 2.2 & 2.3, be re-numbered accordingly.

Note: This amendment to the regulations will be effective 1 July 2021.

All Exhibitors are asked to practice THE 1.5m social distancing requirement at all times where possible. Masks will of course be freely available for Judges and Officials if requested but there is no requirement to wear a mask.

Before judging

- Upon arrival ALL exhibitors and any additional people/guests must check in using the Tasmanian Government QR code. CLUBS please make these available around the grounds and ensure there are multiple copies at the table for exhibit number collection. A pen and paper (this must be sanitised after use) must also be available with name and phone number information collected for anyone not able to use the Tasmanian Government QR code App.; and
- The club is to ensure at least ONE committee person is available to hand out exhibit numbers – reducing any contact across envelopes and ensuring distancing is maintained; and
- The club is to ensure sanitiser is available for use on the office desk; and
- The club is to ensure 1.5m is observed by anyone waiting to check in; and
- TCA Representatives' report paperwork is to include a copy of the current guidelines to ensure adherence to the safety protocol is followed; and
- Entrance and exit gates to be separate and must be strictly monitored.

Judging

- All Judges are to be given advice of the guidelines BEFORE judging;
- The Judge should not shake hands with any exhibitor – use the elbow bump instead;
- The Judge can go over the dog and mouth the dog. If Judges choose to mouth the dog, wipes or sanitiser must be used regularly;
- Stewards are to ensure assembly areas are kept clear with only the next few breeds in the immediate area and
- Sanitiser must be readily available for Judges and Stewards.

General

- A plan must be submitted to the Dogs Tasmania office seven days prior to the fixture detailing how the club will comply with these requirements;
- All areas to be controlled and the current social distancing requirement enforced. Event Managers/Club Officials can suspend activity and request people to leave the grounds or stop the fixture completely if people do not adhere to social distancing rules;

- Committee to ensure there is appropriate soap and paper towel in the toilets throughout the day;
- Any canteen facilities must observe safe food and cash handling (we recommend having one designated person responsible for the cash handling only);
- Hand sanitiser must be available for canteen patrons to use;
- Canteen workers must ensure distancing is observed and
