PRESIDENT'S REPORT

Hi Everyone,

Well activities seem to be getting back to new normal at Dogs Tasmania. Most events have resumed with clubs electing to reduce the number of shows on an individual weekend. Despite the absences of community transmission of COVID-19 in Tasmania we must remain vigilant. It is quite possible for someone to test positive after release from quarantine and return to Tasmania and unknowingly spread the disease. If you are eligible for a jab, take the opportunity as the life you save may be a fellow dog person.

I've had my first jab and now I can return to dog shows, so I will look forward to seeing you all about.

Regardless of one's politics, we need to take any opportunity to source grants to enable our sport to prosper. With the State Government being returned with an absolute majority, we will be working hard to ensure they honour their promise to provide \$200,000 for the dog facilities at Pontville. Obviously it would be cheaper to lay the concrete flooring before the building is erected and one of our objectives is to get the money flowing straight away so this can be done. Those of you who have been to Pontville will have seen the groundworks for the building and noted the location and size of the building. With the building taking place at Pontville there will be a number of changes regarding parking. Please adhere to signage and directions from club officials.

We have been shocked and saddened in the past few weeks by the death of Colin Gillanders and the illness of Katelyn Innes. I attended Colin's funeral, many in the dog world were also there to lend support to Philippa. I am sure all our prayers are with Philippa at this time.

Katelyn's illness came out of the blue and I guess was made all the more devastating because of her youth. FROM THE OFFICE

Breeders are advised that, effective 1 October 2021 and in accordance with ANKC Ltd Regulations Part 6 – The Register and Registrations, Clause 6.2, hereunder stated:

Effective 1 March 2021, it is the breeder/seller's responsibility, when disposing of a puppy/dog, to transfer the ownership of the puppy/dog to the new owner. (Added 01/21, EM#190).

the fee for the registration of each puppy, irrespective of whether it is being retained by the breeder or sold will be \$65.00. This fee includes a 'once off' transfer into the new owner/s' name. This information will be placed on the puppy's file for any unsold puppies and for those retained by the breeder; any puppy/dog subsequently placed will be transferred free of charge

As from 1 May 2021 Tasmanians and visitors will be required to use the Check In TAS app when they visit a range of businesses, organisations and events. The free Check In TAS app is available for download from the Google Play Store and Apple App Store. Exhibitors at TCA Inc sanctioned fixtures are requested to check in using this code. Anyone who does not have a mobile phone should ask friends to check them in or, if all else fails, please report to the office and check in there.

PONTVILLE SPORTS COMPLEX

Parking has been a problem at recent shows – exhibitors are requested **NOT** to park on the area directly around the rings on **ALL** sides. Please use the car park on the southern or northern sides of the area. Anyone ignoring this request will be required to move their vehicle when asked to do so. Please ensure that the area around the toilet/grey water dump point are vacant to allow other users of the area to access the toilets. The only parking permitted in the area in front of the change rooms is for committee members who will park up against the building.

Exhibitors are reminded that all gazebos are to be set back at least 2 metres from the boundary of all rings.

When transferring a puppy/dog to a new owner breeders are reminded of the following TCA Inc Regulations

58.1 A TCA Inc member selling a dog must provide to the purchaser a three (3) generation pedigree/registration document, authorising transfer of the animal in the records of the TCA Inc.

58.1.1 The pedigree/registration document must be supplied to the purchaser within twenty eight (28) days from the date of sale or from the issue date shown on the pedigree/registration document issued by the TCA Inc, whichever date occurs first.

58.1.2 Any TCA Inc member who does not comply with Regulation 58.1 and 58.1.1 shall be liable for a fine in accordance with the TCA penalty guidelines.

The TCA Inc offers a microchipping service throughout the state at a cost of \$20 per dog/puppy (including lifetime registration on a nation-wide data base). Please contact the office for further details.

TCA Inc Constitution

The EO advised the meeting that the second round of submissions had been included into the draft document and that he would organise a meeting of the Working Party.

FINANCE:

The Financial Report for January 2021 showing a Net Profit of \$16624.62 for the month compared to a Net Profit of \$36227.19 for the same period in 2020 and a Bank Register indicating deposits of \$65142.77 and withdrawals of \$12042.51 were circulated to all Councillors.

CORRESPONDENCE:

ANKC Ltd

Notification that the electronic motion making breeders responsible for transferring their puppies into the new owner's name had been approved, effective from 1 March 2021.

The EO advised the meeting that this requirement would not come into effect in Tasmania until 1 October 2021.

Correspondence advising that the ANKC Ltd Regulations Part 6 had been amended to reflect this decision was also tabled.

ANKC Ltd

A copy of correspondence from TT Lines in response to a request that consideration be given to allowing member's trailers to travel at freight rates when travelling with TT Lines advising that motor vehicles, motor homes and caravans are able to travel at a reduced rate under the Bass Strait Passenger Vehicle Equalisation Scheme that did not apply to trailers.

Cradle Coast Kennel Club

Notification that the club was cancelling its fixtures scheduled for 27 and 28 February 2021 and a request for a change of dates from 2 and 3 October 2021 to 11 and 12 September 2021.

- There were 1020 members including Life Members as at 31 January 2020 compared to 1029 in 2020. 39 membership renewal reminders were sent out for January 2021.

Herding Instinct Tests

The EO advised the meeting that S Axton had requested that this matter be listed as an agenda item for this meeting.

S Axton advised that she supported the practice of holding Herding Instinct Tests at training days but felt that the dates should be advertised in the Gazette to allow all members to be advised that they were being held.

The EO advised that he would liaise with T Luttrell regarding the dates.

Conformation Judging

T Sloan suggested that TCA Inc Regulation 127 be looked at with the view of allowing exhibits for the next class to be assembled in the ring while the current class is being judged.

RESOLVED: 'The matter be referred to the Regulations Committee for consideration.'

T Luttrell advised the meeting that there was only one Earthdog Judge in the state making the training of new judges difficult.

The EO advised the meeting that he would contact Dogs Victoria Earthdog Committee regarding their Judges Training Scheme.

CLUB COVID-19 CHECKLIST/REQUIREMENTS FOR CONFORMATION FIXTURES

FOR PEOPLE ATTENDING THE EVENT:

(this information should be displayed in prominent positions)

- In the last 14 days, have you travelled from overseas or a COVID-19 hotspot?
- Have you been in close contact with a person who is positive for COVID-19?
- Are you currently, or have you recently experienced a cough, fever, sore throat, fatigue, or shortness of breath?
- IF YOUR ANSWER IS YES TO ANY OF THE ABOVE PLEASE DO NOT ENTER THE GROUNDS.

All Exhibitors are asked to practice the 1.5m social distancing requirement at all times where possible. Masks will of course be freely available for Judges and Officials if requested but there is no requirement to wear a mask.

Before judging

- Upon arrival ALL exhibitors and any additional people/guests must check in using the Tas Government QR code. CLUBS are required to ensure that the QR Code for the venue is available around the grounds and ensure there are multiple copies at the table for exhibit number collection. A pen and paper (this must be sanitised after use) must also be available with name and phone number information collected for anyone not able to use the Tas Government QR code App.;
- The club is to ensure sanitiser is available for use on the office desk;
- The club is to ensure 1.5m is observed by anyone waiting to check in and
- TCA Representatives' report paperwork is to include a copy of the current guidelines to ensure adherence to the safety protocol is followed.

Judging

- All Judges are to be given advice of the guidelines BEFORE judging;
- The Judge should not shake hands with any exhibitor – use the elbow bump instead;
- The Judge can go over the dog and mouth the dog. If Judges choose to mouth the dog, wipes or sanitiser must be used regularly;
- Stewards are to ensure assembly areas are kept clear with only the next few breeds in the immediate area, and
- Sanitiser must be readily available for Judges and Stewards.

General

- All areas to be controlled and the current social distancing requirement enforced. Event Managers/Club Officials can suspend activity and request people to leave the grounds or stop the fixture completely if people do not adhere to social distancing rules;
- Committee to ensure there is appropriate soap and paper towel in the toilets throughout the day;

- Any canteen facilities must observe safe food and cash handling (we recommend having one designated person responsible for the cash handling only);
- Hand sanitiser must be available for canteen patrons to use, and
- Canteen workers must ensure distancing is observed.

Attending the Event

No one is to attend the event if they have COVID-19 symptoms, stay at home if you are unwell or have a cough, fever, sore throat, fatigue or shortness of breath. If you become unwell during the event locate the Event Manager and advise. It is the exhibitor's responsibility to leave the venue immediately if you become unwell. Substitute Judges:

The affiliate conducting an exhibition reserves the right to substitute judges if the committee deems it necessary. Entry fees are not refundable – refer TCA Inc Regulation 227.

Responding to Activists

STEPS FOR HANDLING CONFRONTATION AT AN EXHIBITION OR EVENT

Proudly show our practices are best practice	Regardless of the risk of confrontation, every exhibitor should proudly uphold the standards expected of us as loving dog owners and members of Dogs Tasmania and present our dogs and ourselves positively.
Advise the show or trial manager, call 000 if needed	Advise the event manager if you believe activists are present and they will advise the local police. If activists create a disruption or confrontation. call 000 immediately. If you call 000 clearly articulate the risk that the activists are posing: to yourself and others, the dogs' welfare, personal and venue property, etc.
Do not engage	Do not engage directly. Keep calm even if provoked and keep your distance if possible.
Ask them to leave	If activists enter the area you are using to house your dogs, speak with them politely to ask them to leave. Acknowledge their right to state their opinions in a lawful manner but ask that they respect your right to continue to look after your dogs' welfare in a safe manner without distress. Ask them to please leave the area and move to a space away from the dogs. They may not respond to the request, but it will make it clear they do not have permission to be there. Do not engage with them further.
Move yourself and your dogs to a safer position	Your safety and welfare and that of your dogs comes first. If activists won't leave, relocate to an area that is safer for you and your dogs.
Create a record	Video footage and photos taken on your phone of the above can be used by police. If there has been damage to property record the details and if possible wait until police have examined the scene before touching anything. Please always consider the safety of yourself and dogs when confronted with activists.
