NOTICE OF ELECTION FOR FOUR (4) TCA INC COUNCILLORS

An election shall be held to elect four (4) Councillors to take office for the period February, 2022 to February, 2025.

A member nominating for election as a Councillor is required to meet the eligibility criteria as defined hereunder. The Commitment Statement must be completed and signed on the nomination form.

No person shall be eligible for election or appointment or be elected or appointed pursuant to this Clause unless the person at the time of closing of nominations:

- (a) Is an ordinary, secondary, pensioner or life member and at least eighteen (18) years of age.
- (b) Has been a member of the TCA Inc, or an ANKC Ltd affiliated body, for a total of at least five (5) years up to and including the closing date for nominations.
- (c) Has served as a member of the Council or the Council of an ANKC Ltd affiliated body; OR has held an executive position on a body affiliated with the TCA Inc for a period or periods in total of not less than two (2) years; OR has held an executive position on a body affiliated with a member body of the ANKC Ltd for a period or periods in total of not less than two (2) years; OR has held an executive position on the committee of a body incorporated under the Act for a period or periods in total of not less than two (2) years, in addition to having held an executive position on a body affiliated with the TCA Inc or with a body affiliated with a member body of the ANKC Ltd, for a period or periods in total of not less than one (1) year.
- (d) Executive positions are those of President, Vice-President, Treasurer and Secretary.
- (e) "ordinary, secondary, pensioner or life member", in relation to this notice, means an eligible member of at least 18 years of age, who is a resident of the state of Tasmania. Whose membership of the TCA Inc is currently financial.

An eligible member of the TCA Inc may cast a vote for not more than four (4) candidates. The four (4) candidates who receive the highest number of votes shall be elected to the vacant positions for a three (3) year term **February 2022 to February 2025**. In the event of a tied vote for the last position the names of those candidates who receive the identical number of votes in the tie shall be subject to a simple draw and the winner of the draw shall be duly declared elected as a Councillor.

Nominations for elections shall be accepted only on the approved nomination form available on the Association's website or from the TCA Inc office and with all the particulars required thereon properly completed.

The nomination must be placed in a sealed envelope marked 'nomination form' and posted to the Returning Officer Locked Bag 1 North Hobart Tasmania 7002 to be received at the Locked Bag not later than the closing time of 12 noon on Friday 29 October 2021.

Please ensure that you allow enough time for Australia Post to deliver your nomination.

The list of nominees shall be published in the December/January issue of the "TCA Inc Gazette", together with the rules, regulations and procedure for voting.

Nominees are invited to submit a photo and a short resume of their involvement in canine activities which will be published free of charge.

A nominee may appoint a person who is a current financial member, as defined in Clause 1 of the Rules for Election, to act as their scrutineer at the counting of votes.

Counting of votes cast in such election shall take place at the Administration Building, Hobart Showground, Glenorchy, on Monday 10 January 2022 commencing at 1.00 pm.

DISTINGUISHED SERVICE AWARD CRITERIA

- 1. The recipient is to have given outstanding service to the canine world over a period of time.
- The recipient is to have been a working member of one or more clubs, having assisted with club canteens, fund-raising, working bees, training days, stewarding, managed or worked in Show Offices, produced club magazines, produced or donated equipment for the membership use.
- 3. Nominations are to be accompanied by a written statement, duly signed by the proposers who must be financial members of the TCA Inc. The nominee's contributions to the canine world must be listed.
- 4. The TCA Inc invites nominations from all disciplines. Nominations will be received up to 31 October each year.
- 5. Up to four awards, at the discretion of Council, will be presented each year. There is no obligation to make any awards each year. Recipients will be advised in writing prior to the presentation. This advice is to be marked 'CONFIDENTIAL'.
- 6. Presentations will be made at a fixture.
- 7. The TCA Inc Council decision is final. No correspondence will be entered into under any circumstances.
- 8. No serving Councillor will be eligible for this award.

CONFORMATION STEWARDS COMMITTEE

After a bit of confusion due to a scheduling clash the Stewards Committee conducted their second meeting for the year at the conclusion of the meeting conducted by the Judges Training Committee at Ross on Saturday 18 September.

An important item on the agenda was the scheduling of training lectures and it was decided, at this stage, since we currently have applicants from those areas, to conduct one in the North West and another in the South. The southern lecture will quite possibly need to be delayed slightly until the move to the new TCA office premises is completed as, I believe, there is a room there that will be ideally suited for the purpose, but that in the NW will take place at the canteen at Ulverstone Showgrounds at 7.00 pm on Tuesday 5 October.

Another item for discussion was about a new venture into a slightly different form of training in the first half of 2022. We are unable to reveal the details until it has been to Council but hopefully it will meet with their approval. We will keep you posted via the Tas Conformation Stewards Group on Facebook. This group is open to all TCA members (not just stewards).

By now all stewards should have received, by email from the office, a copy of the Conformation Stewards Guide. If not, please contact the office and request a copy be sent to you. The committee wish to strongly encourage ALL stewards, new and not so new, to take the time to read through this guide thoroughly and make sure you are familiar and up to date with those regulations pertaining to stewarding and ring procedure.

PRESIDENT'S REPORT

Hi Everyone

I am really pleased to be able to report that the three promises that the Council made to members at the Special General Meeting in May 2017 at which a petition signed by some members was defeated have finally be fulfilled.

The Council promised to upgrade the electoral provisions of the Constitution, commission a review of the procedures and staffing of the office and then undertake a complete review of the Constitution

The electoral provision review was undertaken promptly and was in place for the next election. This basically put the electoral process at arm's length from the office.

Later in the year the review of the office was undertaken. The report was very positive and it was posted on our website for members to read. The only confidential section related to staff salaries.

Finally, four years later after a process which involved three lots of consultation with members, a Special General Meeting on Tuesday 21 September, 2021 ratified the new Constitution.

I would like to thank the two members who spent incalculable hours on the task and thanks also to those members who made submissions.

It is also very pleasing to advise that we have found a new home for our office. RAST had advised us that the building we are housed in is to be demolished as part of the development program for the Showground which necessitated a search for new premises. The new offices are at 77 Chapel Street Glenorchy and should be fully operational by the end of October. Once the move is completed you will be welcome to drop in for a look around. Probably the best news for members, is that the library can be accommodated and there is a room suitable for club meetings.

There is a notice in this Gazette for nominations for the election of Councillors in 2022. If you are interested make sure you meet the requirements. Under the new system, nominations are not opened until the nomination period has closed and if you don't conform to the criteria, your nomination will be ruled invalid with no opportunity of rectifying the error.

It appears likely that there will be an ongoing problem with getting interstate judges for a while yet. Council recently changed the regulations to make it easier to get a local judge, however Council expects clubs to continue to try to source interstate judges so that the locals are available to fill in if there are new breakouts of the virus, interstate.

Unfortunately, Launceston Royal has been cancelled but Hobart is going ahead. When I am writing this, entries are about close and in the circumstances with essentially no interstate entries the numbers are surprisingly good.

Hopefully we will not lose too many events over summer so enjoy.

FROM THE OFFICE

Members are reminded that, **as from 1 October 2021**, puppies from any litters lodged for registration on and after this date must be transferred into the name of the new owner. A new form will be available on the website or copies can be obtained from this office. Any puppies not sold or retained by the breeder will be registered in the breeder's name and their file noted that there is a transfer to be processed at no cost.

We have finally found alternative offices at 77 Chapel Street, Glenorchy; we hope to be moved in by 15 October 2021. The office may have to close for a few days just prior and the phones and e-mail may be offline as well. We will advise members of any disruptions to normal office procedures via the Facebook page.

The TCA Inc office will not close for the week of the Royal Hobart Show as it has previously done but will be closed 21 (Royal Hobart Show Public Holiday) and 22 October 2021.

CONFORMATION STEWARDS PANEL

Miss Rebecca Bentley has been included onto the panel as a Ring Steward – 0433 921 290.

Members are advised of the following changes to the TCA Inc Regulations, effective from 16 August 2021:

140 A judge shall not be permitted to award Challenge Certificates to the same sex of the breed within a period which is six (6) months prior to the date of the show in the same region. For the purposes of this regulation, Region 1 is south of 42 degrees south and Region 2 is north of 42 degrees south. The TCA Inc. Council may grant an exemption under exceptional circumstances Note that Oatlands is marginally south of 42 degrees south.

174B Notwithstanding, clause 174A, where All Breeds Sweepstakes are scheduled at a Show or Parade they may be judged by a judge who is licensed in at least two (2) Championship groups provided the judge also holds 2 (two) additional Open Show Group Licenses. Provided these sweepstakes are finalised before the General Classes at the Show commence, these judges may exhibit in General Classes at the exhibition. Judges judging at Sweepstakes arranged under this clause may not award challenge certificates at the same exhibit.

- **217** An affiliate may postpone or cancel an event subject to confirmation by the Tasmanian Canine Association
- **217a** If after the closing date of entries, an exhibition is postponed for not more than 15 days including weekends, the event shall continue as if it was held on the day originally advertised. Entries must not be reopened. Exhibits will remain in the classes for which they were entered and the affiliate running the show may determine whether any refunds of entry fees will be made.
- **217b** If after the closing date of entries, an exhibition is postponed for more than 15 days the entries must be re-opened, exhibits ages shall be adjusted to the rescheduled date and withdrawal of entries with refund of entry fees must be permitted.
- **217c** If an exhibition is postponed prior to the closing of entries, the closing date for entries shall be extended exhibits already entered may be withdrawn and the entry fee shall be refunded.
- **217d** If an event is cancelled before entries have closed all entry fees must be refunded If an event is cancelled after entries have closed the affiliate shall refund 75% of the entry fee to exhibitors. If the affiliate incurs unusual expenses this % may be varied by the TCA Inc Council upon request.
- **251** Affiliates conducting Tracking or Track & Search trials may run those trials over more than one (1) day.
- **252.1** The precinct of a Tracking or Track & Search Trial is the area defined by the Trial Committee conducting the exhibition.
- **252.2** No visitor's dog shall be permitted to be removed from a vehicle on a trial site at a Tracking or Track & Search Trial until a club official is available to check for bitches in oestrum.
- **252.3** All dogs at a Tracking or Track & Search shall be retained on lead at all times.

- In the last 14 days, have you travelled from overseas or a COVID-19 hotspot?
- Have you been in close contact with a person who is positive for COVID-19?
- Are you currently, or have you recently experienced a cough, fever, sore throat, fatigue, or shortness of breath?
- IF YOUR ANSWER IS YES TO ANY OF THE ABOVE PLEASE DO NOT ENTER THE GROUNDS.

All Exhibitors are asked to practice the 1.5m social distancing requirement at all times where possible. Masks will of course be freely available for Judges and Officials if requested but there is no requirement to wear a mask.

Before judging

- Upon arrival ALL exhibitors and any additional people/guests must check in using the Tas Government QR code. CLUBS are required to ensure that the QR Code for the venue is available around the grounds and ensure there are multiple copies at the table for exhibit number collection. A pen and paper (this must be sanitised after use) must also be available with name and phone number information collected for anyone not able to use the Tas Government QR code App.;
- The club is to ensure sanitiser is available for use on the office desk;
- The club is to ensure 1.5m is observed by anyone waiting to check in and
- TCA Representatives' report paperwork is to include a copy of the current guidelines to
 ensure adherence to the safety protocol is followed.

Judging

- All Judges are to be given advice of the guidelines BEFORE judging;
- The Judge should not shake hands with any exhibitor use the elbow bump instead;
- The Judge can go over the dog and mouth the dog. If Judges choose to mouth the dog, wipes or sanitiser must be used regularly;
- Stewards are to ensure assembly areas are kept clear with only the next few breeds in the immediate area, and
- Sanitiser must be readily available for Judges and Stewards.

General

- All areas to be controlled and the current social distancing requirement enforced. Event
 Managers/Club Officials can suspend activity and request people to leave the grounds or
 stop the fixture completely if people do not adhere to social distancing rules;
- Committee to ensure there is appropriate soap and paper towel in the toilets throughout the day;
- Any canteen facilities must observe safe food and cash handling (we recommend having one designated person responsible for the cash handling only);


