NOTICE OF BY-ELECTION FOR TWO (2) TCA INC COUNCILLORS

A by-election shall be held to elect two (2) Councillors to take office for the period March, 2022 to February, 2025.

A member nominating for election as a Councillor is required to meet the eligibility criteria as defined hereunder. The Commitment Statement must be completed and signed on the nomination form.

No person shall be eligible for election or appointment or be elected or appointed pursuant to this Clause unless the person at the time of closing of nominations:

- (a) Is an ordinary, secondary, pensioner or life member and at least eighteen (18) years of age.
- (b) Has been a member of the TCA Inc, or an ANKC Ltd affiliated body, for a total of at least five (5) years up to and including the closing date for nominations.
- (c) Has served as a member of the Council or the Council of an ANKC Ltd affiliated body; OR has held an executive position on a body affiliated with the TCA Inc for a period or periods in total of not less than two (2) years; OR has held an executive position on a body affiliated with a member body of the ANKC Ltd for a period or periods in total of not less than two (2) years; OR has held an executive position on the committee of a body incorporated under the Act for a period or periods in total of not less than two (2) years, in addition to having held an executive position on a body affiliated with the TCA Inc or with a body affiliated with a member body of the ANKC Ltd, for a period or periods in total of not less than one (1) year.
- (d) Executive positions are those of President, Vice-President, Treasurer and Secretary.
- (e) "ordinary, secondary, pensioner or life member", in relation to this notice, means an eligible member of at least 18 years of age, who is a resident of the state of Tasmania. Whose membership of the TCA Inc is currently financial.

An eligible member of the TCA Inc may cast a vote for not more than two (2) candidates. The two (2) candidates who receive the highest number of votes shall be elected to the vacant positions for a three (3) year term **March 2022 to February 2025**. In the event of a tied vote for the last position the names of those candidates who receive the identical number of votes in the tie shall be subject to a simple draw and the winner of the draw shall be duly declared elected as a Councillor.

Nominations for elections shall be accepted only on the approved nomination form available on the Association's website or from the TCA Inc office and with all the particulars required thereon properly completed.

The nomination must be placed in a sealed envelope marked 'nomination form' and posted to the Returning Officer Locked Bag 1 North Hobart Tasmania 7002 to be received at the Locked Bag not later than the closing time of 12 noon on Monday 10 January 2022. Please ensure that you allow enough time for Australia Post to deliver your nomination.

The list of nominees shall be published in the February/March 2022 issue of the "TCA Inc Gazette", together with the rules, regulations and procedure for voting.

Nominees are invited to submit a photo and a short resume of their involvement in canine activities which will be published free of charge.

A nominee may appoint a person who is a current financial member, as defined in Clause 1 of the Rules for Election, to act as their scrutineer at the counting of votes.

Counting of votes cast in such election shall take place at the Administration Building, Hobart Showground, Glenorchy, **on Friday 4 March 2022 commencing at 1.00 pm.**

will be held at the Perth Community Centre, Perth, on Monday, 14 March 2022 commencing at 10.30 am.

President's report



Hi Everyone

Our Board Election took place during October. Unfortunately only two valid nominations were received at the close of nominations. Nonetheless, welcome back to Sue Axton and Pat Hallam. Under our Constitution we are required to have a by-election to fill the two vacant places. Details of the by-election are included in this gazette.

The Constitution recently adopted by the Special General Meeting has been approved by Corporate Affairs. The by-election will be conducted under the new Constitution. There was little change to the electoral provisions, the main one being a slight relaxation of the qualifications to stand.

The ANKC has commenced its relaunching as Dogs Australia. This will be an ongoing program to extoll the virtues of purebred dogs and try and combat the many scammers that have been attracted to our hobby by the rising prices for puppies and the apparent desire of people to add a dog to their family. The office gets at least three calls a week about whether puppies for sale are genuine and it is amazing how many of them have actually parted with their money before they realise they may have been scammed.

The Dogs Australia Board held their Annual Meeting in October. A summary of the significant decisions is in this gazette. The most controversial decision will be the recognition of the Australasian Bosdog (Group 7) and the Murray River Retriever (Group 3) as new breeds on the Development Register. In addition the Biewer (pronounced beaver) Terrier has arrived in Australia and will be shown in Group 1.

Of course, the other major news was the move of the office to 77 Chapel Street, Glenorchy during October. Everyone who has called in has been very impressed and I am sure the greatly improved working conditions will raise the excellent service we receive from the staff to an even higher level.

Work on the new building at Pontville – the delay now seems to be with Brighton Council. I know a number of our members are keeping their finger on the pulse and trying to keep things moving as quickly as possible.

Conformation practical exams will be over by the time you read this. I hope all four candidates are successful. I know the amount of work they have put in over the year and they deserve a reward for their efforts.

Also a note to affiliates bringing judges in from New South Wales, Victoria and Australian Capital Territory after 15 December 2021. At this stage they require a negative test in the 72 hours before they arrive. It doesn't seem clear yet about which tests are acceptable but it appears they may have to be done privately an we understand the cost is about \$150 which will have to be picked up by the club. Regardless, clubs with interstate judges contracted should contact them to ensure they are fully vaccinated and if necessary, they are willing to have a test done. We may have some judges contracted who can't or don't want to meet that criteria.

In conclusion, I would like on behalf of the Council and Staff, wish all our members an enjoyable festive season and be careful with COVID after the borders re-open.

RULES - PUPPY OF THE YEAR

For the 2022 Qualifying Year - Final 2023

- Exhibit qualifies by winning either a Minor or Puppy In Group award at any All Breeds Championship Show or Group Show in Tasmania from 1 of January till 31 December each year.
- 2. All exhibits have to be in exhibitors name or co-owned/leased by an exhibitor who is a financial member of Dogs Tasmania at the time of the dog's win.
- 3. Puppies can qualify two years in a row but if same exhibit has won the POTY in the previous year it will be ineligible.
- 4. Competition will be held in February/March each year.
- 5. Invitation will be extended via the December issue of *The Gazette*.
- 6. Depending on entries received each dog will be entered in a heat of up to a maximum of five dogs, with two heats making up one round.
- 7. There will be two judges and each dog will be assessed by each judge in each heat of the round
- 8. Dogs once handed over to the respective judge must compete and be assessed in both heats of the round.
- 9. There will be one winner from each heat that progress through to the next round.
- 10. There will be an outright winner only, no runner-up.

Breeders who have the parentage of their litters verified by DNA testing are advised that the puppies' pedigrees can have the notation 'PARENTAGE VERIFIED BY DNA TESTING' if requested. Please ensure that the DNA results are forwarded with the litter application.

Members are reminded of the requirements set down in the Department of Primary Industries, Water and the Environment Animal Welfare (Dogs) Regulations 2016 that, as a member of the TCA Inc, you are required to comply with these conditions for keeping/breeding dogs.

When submitting paperwork to the office for processing members are requested to ensure that their writing is of an appropriate size and legible. Any applications that do not comply with these requirements will be returned for correction.

SUMMARY OF THE ANKC LTD ANNUAL GENERAL MEETING & BOARD MEETING HELD VIA ZOOM VIDEO CONFERENCING 16 OCTOBER 2021

At the recent Annual General Meeting of the Australian National Kennel Council Limited held via Zoom video conferencing:

1. Election of ANKC Ltd Executive

- Mr Hugh Gent OAM was re-elected unopposed as President for a three-year term from 16 October 2021;
- Ms Pam Campbell was elected unopposed as Vice President for a one-year term from 16 October 2021;
- Mr David Sales was re-elected unopposed as Treasurer for a one-year term from 16 October 2021.
- Mrs Ulla Greenwood was elected as a member of the Executive Committee for a one-year term from 16 October 2021.

At the October 2021 ANKC Ltd Board meeting, Directors resolved/considered the following:

1. Dances with Dogs Judges - FCI Judges Listing

FCI has confirmed all FCI discipline judges can be added to the FCI Judges Directory if they comply with FCI qualifications. A notice will be distributed to ANKC Member Bodies in due course confirming how interested Australian judges can arrange to be included on the Directory.

2. Murray River Retriever - Recognition

It was resolved to formerly recognise the Murray River Retriever as a breed under development as from 1 January 2022 in accordance with Regulations Part 6 – The Register & Registration, Section 10.

3. Australasian Bosdog - Recognition

It was resolved to formerly recognise the Australasian Bosdog as a breed under development as from 1 January 2022 in accordance with Regulations Part 6 – The Register & Registration, Section 10.

4. Rottweiler Breed Survey

It was resolved that ANKC conduct a survey of all Rottweiler breeders and owners to determine whether the dogs with natural bob tails should be placed on the Limited Register. The results of the survey will be considered by the ANKC Board.

5. Jack Russell Terrier Survey

It was resolved that the results of the Jack Russell Terrier survey be endorsed and for the breed standard to be amended as follows:

Body

Chest deep rather than wide, with good clearance and the brisket located at the height midway between the ground and the withers. The body should be proportioned marginally longer than tall, measuring slightly longer from the withers to the root of the tail than from the withers to the ground the length from the point of the shoulder to the buttocks slightly greater than the height from the withers to the ground. Back level. Ribs should be well sprung from the spine, flattening on the sides so that the girth behind the elbows can be spanned by two hands – about 40 cms to 43 cms. The loins should be short, strong and deeply muscled.

The change will be to replace the wording underlined with the highlighted wording in bold. To be effective immediately.

7. Identification of Natural Bob Tail (NBT) on the ANKC Ltd Business System

It was resolved that the recorded information of Natural Bob Tail, identified on the pedigree database as 'NBT', as part of the printed information that appears as part of a dog's registered name or number, ensuring that this information is included in relation to their official identification.

To be effective from 1 July 2022.

- 3. Each year the number of judges to be appointed shall be determined by the committee of the Combined Breeds Dog Club of Tasmania Inc.
- 4. The judges will be selected by an independent member on behalf of the committee of the Combined Breeds Dog Club of Tasmania Inc. The Judges will be announced on the night.
- For dogs/bitches to compete at the Contest of Champions all qualifying points must be obtained at Tasmanian shows.
- 6. Dogs/bitches must gain their wins in Tasmania but do not have to be owned outright by a resident of Tasmania. Dogs/bitches, at the time of qualifying, wholly owned by a person/s not resident in Tasmania are ineligible.
- 7. There will be 32 invitations issued to the top qualifying dogs on the following basis: Invitations will be issued to the top 32 dogs ALL BREEDS

Scoring for these positions will be as follows:

Best in Show4 pointsRunner Up Best in Show3 PointsBest in Group2 PointsRunner Up In Group1 Point

(Maximum of 4 points per show)

- If any dog/bitch invited cancels, withdraws or does not accept the invitation an
 invitation will be issued to the next highest scoring exhibit.
- 8. Invitations will be forwarded to exhibitors as soon as possible but no later than 15 January in each year.
- 9. Judging will be by means of a knock out competition, 16 heats with the winner of each heat going through to the next round until two only remain. There will be one final winner. The order of judging will be determined by a public draw at the event prior to the commencement of judging.
- 10. The TCA Inc Council will appoint an independent adjudicator for the event.
- 11. In the event of any contingency arising which is not covered by these Regulations the club's committee, in conjunction with the TCA Inc appointed adjudicator, has the power to make such rulings as they determine are in the best interests of the club and the continuing prestige of the event.

Before judging

A pen and paper (this must be sanitised after use) must also be available with name and phone number information collected for anyone not able to use the Tas Government QR code App.;
- The club is to ensure sanitiser is available for use on the office desk:

Judging

- All Judges are to be given advice of the guidelines BEFORE judging;
- The Judge should not shake hands with any exhibitor use the elbow bump instead;
- The Judge can go over the dog and mouth the dog. If Judges choose to mouth the dog, wipes or sanitiser must be used regularly;
- Stewards are to ensure assembly areas are kept clear with only the next few breeds in the immediate
 area, and
- Sanitiser must be readily available for Judges and Stewards.

General

- All areas to be controlled and the current social distancing requirement enforced. Event Managers/ Club Officials can suspend activity and request people to leave the grounds or stop the fixture completely if people do not adhere to social distancing rules;
- Committee to ensure there is appropriate soap and paper towel in the toilets throughout the day;
- Any canteen facilities must observe safe food and cash handling (we recommend having one

Responding to Activists STEPS FOR HANDLING CONFRONTATION AT AN EXHIBITION OR EVENT

Proudly show our practices are best practice	Regardless of the risk of confrontation, every exhibitor should proudly uphold the standards expected of us as loving dog owners and members of Dogs Tasmania and present our dogs and ourselves positively.
Advise the show or trial manager, call 000 if needed	Advise the event manager if you believe activists are present and they will advise the local police. If activists create a disruption or confrontation. call 000 immediately. If you call 000 clearly articulate the risk that the activists are posing: to yourself and others, the dogs' welfare, personal and venue property, etc.
Do not engage	Do not engage directly. Keep calm even if provoked and keep your distance if possible.
Ask them to leave	If activists enter the area you are using to house your dogs, speak with them politely to ask them to leave. Acknowledge their right to state their opinions in a lawful manner but ask that they respect your right to continue to look after your dogs' welfare in a safe manner without distress. Ask them to please leave the area and move to a space away from the dogs. They may not respond to the request, but it will make it clear they do not have permission to be there. Do not engage with them further.
Move yourself and your dogs to a safer position	Your safety and welfare and that of your dogs comes first. If activists won't leave, relocate to an area that is safer for you and your dogs.
Create a record	Video footage and photos taken on your phone of the above can be used by police. If there has been damage to property record the details and if possible wait until police have examined the scene before touching anything. Please always consider the safety of yourself and dogs when confronted with activists.

At least one parent or guardian is required to be a financial member of the TCA Inc.

Entry fees must accompany the entry form and should be paid by cheque or money order (refer Australia Post regulation).

Substitute Judges:

The affiliate conducting an exhibition reserves the right to substitute judges if the committee deems it necessary. Entry fees are not refundable – refer TCA Inc Regulation 227.

It is the exhibitor's responsibility to have his/her exhibit/s available for judging in all classes or events for which it is correctly entered and for the classes for which it subsequently becomes eligible – TCA Inc Regulation 33.


