PRESIDENT'S REPORT

Hi Everyone

After many years of alternating Council Meetings between Ross and Oatlands due to different problems at both of those locations, the Council has been seeking a different venue. The last two meetings have been held at Tunbridge Community Centre and it has proved most suitable. The Council has agreed that all future face to face meetings will be held there. Obviously Zoom Meetings will be held when the weather makes the roads dangerous.

Now that the review of the Constitution has been completed, work has commenced on reviewing the regulations. This is a mammoth task but it is hoped that draft will be available for member consultation during 2023.

The Council has approved the affiliation of a new Club i.e. The Canine Conformation Club of Tasmania (CCTCT). Its aim is to provide training for conformation participants. It will for the present take over the dates of the Judges Training Committee and will be the only All Breeds Club that is not location based and is able to hold shows in any part of the state.

As advised at the AGM, the most imperative task for Dogs Tasmania is to commence some sort of monitoring process for our breeders. When the EO and I attended a meeting of AWAC, it was made clear to us that unless we could show we were monitoring the standards set for our breeders, it was possible in the current regular review of the AWA Act, some of the more unwelcome features of legislation from interstate may be considered. The Council is giving considerable thought on how this may be introduced in an efficient and effective manner that is fair to our members.

Most people are doing the right thing but could I implore members attending events at Pontville to follow instructions regarding parking especially while the "shed" is under construction. Speaking of the shed, we continue to request updates from Brighton Council and have made the fact very clear that we need the shed completed.

We are approaching the end of the financial year, so Club AGMs are just around the corner. All Clubs seem to be operating with skeleton Committees. How about joining a Club and even if you don't want to go on the Committee, there are lots of jobs that they would appreciate help with.

The ANKC has not yet progressed the standardisation of ramp requirements and it is unlikely to occur before October. There is nothing to prevent Clubs using ramps at present but Dogs Tasmania has delayed ordering ramps until the specifications are known. A number of Clubs have agreed to meet the cost of a ramp when this occurs.

There have been a number of new breeds approved. The Prague Ratter, Miniature American Shepherd, Australasian Bosdog and the Murray Valley Retriever. It should be noted that although they can receive challenges, they are only on the FCI Provisional Register and are not eligible for CACIBs at FCI Shows. This also applies to the Stumpy Tailed Cattle Dog, Tenterfield Terrier and the Yakutian Laika

I will repeat exactly what was in my February Report:

Members are reminded of the problems with puppy scammers "stealing" membership numbers to include in advertisements for puppies. The office continues to receive calls from people who have parted with their money and there is no puppy. Part of the Dogs Australia project is to make potential puppy buyers aware of the dos and don'ts of puppy buying. Watch the podcast on the Dogs Australia website.

This is still happening.

Anyone who hasn't called into the new office, is welcome to drop in for a look around. The Library custodians are doing a fantastic job and the library will be open to members by appointment.

Although it has dropped off the front pages, the COVID epidemic seems to just keep rolling on though fortunately with the mass inoculations, the consequences don't seem to be so dire. Please continue to do all the right thing, masks inside, social distancing, staying home when you feel unwell, etc. We need to keep everyone safe.

Drive safely in the winter conditions and enjoy your canine accomplices.

Responding to Activists

STEPS FOR HANDLING CONFRONTATION AT AN EXHIBITION OR EVENT

Proudly show our practices are best practice	Regardless of the risk of confrontation, every exhibitor should proudly uphold the standards expected of us as loving dog owners and members of Dogs Tasmania and present our dogs and ourselves positively.
Advise the show or trial manager, call 000 if needed	Advise the event manager if you believe activists are present and they will advise the local police. If activists create a disruption or confrontation. call 000 immediately. If you call 000 clearly articulate the risk that the activists are posing: to yourself and others, the dogs' welfare, personal and venue property, etc.
Do not engage	Do not engage directly. Keep calm even if provoked and keep your distance if possible.
Ask them to leave	If activists enter the area you are using to house your dogs, speak with them politely to ask them to leave. Acknowledge their right to state their opinions in a lawful manner but ask that they respect your right to continue to look after your dogs' welfare in a safe manner without distress. Ask them to please leave the area and move to a space away from the dogs. They may not respond to the request, but it will make it clear they do not have permission to be there. Do not engage with them further.
Move yourself and your dogs to a safer position	Your safety and welfare and that of your dogs comes first. If activists won't leave, relocate to an area that is safer for you and your dogs.
Create a record	Video footage and photos taken on your phone of the above can be used by police. If there has been damage to property record the details and if possible wait until police have examined the scene before touching anything. Please always consider the safety of yourself and dogs when confronted with activists.

REGULATION AMENDMENTS EFFECTIVE 1 JULY 2022

- 17C MISCONDUCT** – means any act or behaviour which is deemed to be unsportsmanlike or of a nature which is contrary to the Regulations, Code of Ethics and/or Social Media Policy of the Tasmanian Canine Association Inc or the Australian National Kennel Council Inc.
- 33** All awards and prizes won shall be forfeited, if a dog is not shown in all other classes for which it subsequently becomes eligible, unless required to withdraw. The Affiliate shall retain all awards and prizes forfeited and forward them to the office of the TCA Inc. The TCA Inc may upon receipt of the Event Manager's report suspend an exhibit from Competition for a breach of this Regulation.
- 33 (b)** The winners of a Best Exhibit in Group award or a Class in Group award are required to be exhibited in the judging of Best in Show or respective Class in Show, and if such exhibit is not so exhibited all awards and prizes won by such dog in other classes at such Show shall be automatically cancelled. All cases in which, pursuant to this Regulation, an award or prize is cancelled, must be reported by the Event Manager to the TCA Inc within three working days of the conclusion of the Show. The winner of a Runner-Up in Group award which is not a Class in Group winner is not required by the Regulations to be exhibited in the judging of Runner-Up in Show but may do so at the option of the exhibitor.
- 93** Any person causing annoyance by unsportsmanlike, threatening, or abusive behaviour, whether verbal or physical and or loud comments, whilst within the precincts of a sanctioned event may be reported for misconduct by a judge, steward, member of the TCA Inc, or another ANKC Inc member body, or a member of the public. Said complaint is to be lodged in accordance with TCA Inc Regulation 96.
- 96** A complaint may be lodged against any member of the TCA Inc for breaches of these Regulations and its Code of Ethics, by members of the TCA Inc or another Controlling Body or a member of the general public as follows:-
In respect of an alleged breach which occurs at a sanctioned event the complainant must either:
- i) Lodge the complaint in writing with the Event Manager on the day of the event including all details of the alleged breach, names and addresses of witnesses and any other supporting documentation.
 - ii) If the complaint is lodged on the day with the Event Manager it must be accompanied by a fee of one penalty unit on the day and four penalty units must be paid to the TCA Inc Office within seven (7) days (if the complainant does not forward the four penalty units within seven (7) days then the one penalty unit will be forfeited).
or if the complaint is not lodged on the day of the fixture it must be in writing and received at the TCA Inc Office within seven (7) days of the alleged breach and accompanied by a fee of five penalty units.
 - iii) When a complaint is lodged by a club official, judge, steward in the course of their official duties or non-member of the TCA Inc or another member body a fee is not required.
 - iv) Where a valid complaint is lodged under this Regulation, the TCA Inc shall investigate the complaint and determine the complaint in accordance with the Constitution and Regulations of the TCA Inc. A copy of the complaint will be sent to the member against who the complaint has been made to enable them to provide a response to the allegations. No complaint will be investigated unless the appropriate fee is paid.
 - v) The fee paid to lodge the complaint will be refunded to the complainant only if the complaint is upheld.
 - vi) On receipt of a complaint the person/s against whom the complaint has been laid will be advised in writing within twenty-eight (28) days by the Executive Officer that a complaint has been received at the TCA Inc Office.
- 96A** A complaint may be lodged against any member of the TCA Inc for breaches of these Regulations and its Code of Ethics, that has not occurred at a sanctioned event, by members of the TCA Inc or another controlling body or a member of the general public as follows:-
In respect of an alleged breach which does not occur at a sanctioned event the complainant must:-
- i) Lodge the complaint in writing to the office of the TCA Inc within seven (7) days of the alleged breach, names and addresses of witnesses and any supporting documentation;

- ii) The complaint must be accompanied by a fee of five penalty units.
 - iii) When a complaint is lodged by a club official, judge, steward in the course of their official duties or non-member of the TCA Inc or another member body a fee is not required.
 - iv) Where a valid complaint is lodged under this Regulation, the TCA Inc shall investigate the complaint and determine the complaint in accordance with the Constitution and Regulations of the TCA Inc. A copy of the complaint will be sent to the member against who the complaint has been made to enable them to provide a response to the allegations. No complaint will be investigated unless the appropriate fee is paid.
 - v) The fee paid to lodge the complaint will be refunded to the complainant only if the complaint is upheld.
 - vi) On receipt of a complaint the person/s against whom the complaint has been laid will be advised in writing within twenty-eight (28) days by the Executive Officer that a complaint has been received at the TCA Inc Office.
- 118 A member of the TCA Inc who accepts a deposit with an order for a puppy must on request refund such deposit in full:-
- i) If the contract of sale cannot be fulfilled by the Breeder within a period which is eight (8) weeks after the whelping of the litter for which the deposit for the puppy is paid or;
 - ii) After six (6) months from when the deposit was paid.
- 123 The following classes may be offered at all Conformation fixtures:-
SWEEPSTAKES – For exhibits of either sex of each breed exhibited at a Show which has been entered in at least one Breed Class at such Show (except dogs entered in a Veterans Sweepstakes). Judges Training Sweepstakes exempt. Where an entry fee is charged at least 50% of the total shall be returned as prize money.
- 127 A steward is to assemble the exhibits for a class by calling the exhibit number in such a manner that the handler ought to have reasonably heard the call. Three calls are deemed to be sufficient notice. The onus is on the exhibitor to be present at the ring when required, and to wear the exhibit number applicable to the exhibit being handled.
Where practical the steward may place the assembled dogs in an appropriate part of the ring prior to the previous class exiting the ring.
- 127.1 Stewards must not hold up judging for any exhibitor other than a quick change of handler/dog. Once the class before has been placed the next class should be ready. Once a class has entered the ring no other handler/dog may enter the ring.
- 127.2 An exhibit will be declared absent by the ring steward if its number has not been acknowledged and the exhibit is not present in the ring at the time when the ring steward consigns the class to the judge for the commencement of judging of that class. If a steward declares an exhibit absent the judge has no authority to override the steward's action.
- 129.3 *Baiting and feeding of dogs in the conformation judging ring will be permitted. Bait is any food item used to attract the attention of the exhibit. However a judge has the right to prohibit baiting. Dropping or throwing of bait is not permitted.*
- 129.4 The use of objects in the conformation ring to attract attention is permitted but must not be used in such a manner that it distracts other exhibits.
- 129.5 When a Ring Steward becomes aware or is advised that an exhibitor is dropping/throwing bait, or using an object in a manner that distracts other exhibits the steward must first warn the offender and request that they pick up the bait, or to cease using the object. If the exhibitor continues to throw/drop bait or use an object in a distracting manner the Ring Steward shall be empowered to suspend judging and order the removal of the exhibitor and exhibit from the judging ring. An affiliate may impose a penalty not exceeding two units (as per the current 'Scale of Charges') for breaches of this Regulation.
- 154 Where a judge is adjudicating on an exhibit for the first time they must examine each exhibit, in the conventional manner by physically handling and moving the exhibit to check its conformation and temperament:-
- i) At a single exhibition held over one or more days, or;
 - ii) At consecutive exhibitions held on one day.
- If a judge defaults in complying with the Regulation it shall be the responsibility of the ring steward to inform the judge of this regulation. If a judge again refuses to comply with this regulation then the steward must call for judging to cease and bring the matter to the attention of the Event Manager who will resolve the matter with the judge.

The Committee has the power to substitute the judge and must report the matter to the TCA Inc Council if the judge completely refuses to comply with this regulation.

- 155** The number of Championship Shows, Open Shows and Parades allocated to clubs/associations shall be determined by the TCA Inc Council each year.
- 159** Clubs based south of latitude 42 degrees south with the exception of Huon and Channel Kennel Club Inc and Southern Midlands Kennel Club, shall conduct their Shows, Open Shows and Parades at the Kennel Section Pontville Sports Centre except with permission of the TCA Inc Council. The 160 clubs based north of latitude 42 degrees south shall conduct their Shows, Open Shows or Parades at such grounds as may be provided, subject to approval of the TCA Inc Council.
- 162** All rings must be clearly numbered for identification. All rings shall be a minimum of 200 square metres with a minimum width of 10 metres.
- 174A** Only judges who are licenced in at least four (4) Championship groups are eligible to judge Sweepstakes classes at an All Breeds Championship Show. Sweepstakes judges should be published in the schedule. If this is not possible they must be announced prior to the closing date of the Show.
- 195** The precinct of a Field or Retrieving Trial is defined as the boundaries of the property used for the fixture.
- 217d** If an event is cancelled before entries have closed all entry fees must be refunded. If an event is cancelled after entries have closed the affiliate shall refund 75% of the entry fee to exhibitors. If the affiliate incurs unusual expenses this percentage may be varied by the TCA Inc Council on request. If a schedule for an event is published in the *TCA Inc Gazette* the advertising fee must be paid.
- 219** If the committee of an affiliate determines that they going to prevent a TCA Inc member from attending their fixture/s the decision must be made at a properly convened meeting of the club committee. This decision must be communicated to the TCA Inc Council in writing with copies of the Minutes of the Meeting and any other relevant documentation.
- 219.1** The period of refusal must be determined in calendar months. The club must continue to allow the member/s to attend their fixture/s until such time as it receives advice in writing that the TCA Inc has approved the action of the club. The penalty imposed by the club will commence from the date of this written advice.
- 219.2** If an appeal against the decision is lodged, with the TCA Inc Council, the Appeals Committee will consider the appeal and make a determination which shall be binding on both parties.
- 227.1** No dogs shall be transferred from one judge to another prior to the exhibition unless the entry is excessive or the scheduled judge is unable to meet the judging commitment. An affiliate must notify the TCA Inc and also where possible in writing seven (7) days prior to the exhibition, all exhibitors affected by a change of judge. Where the judge announced in the schedule is altered, an exhibitor may withdraw from exhibition before commencement of judging by the substitute judge but shall not be entitled to a refund of entry fees.
- 227.2** Judges who are listed in the schedule must judge the groups/breeds that they are advertised to judge unless in accordance with Regulation 227.1. Judges listed in the schedule may judge additional groups/breeds if required. Where changes are made every effort should be made to have judging of a group/breed take place at approximately the same time of day as originally scheduled. The TCA should be advised of any changes as soon as practicable.
- 235.1** **Conformation Clubs** are required to allocate excluding sponsors product, the value of 25% of the total entry fees received towards sashes/trophies (except clubs conducting Shows in accordance with ANKC Regulations Show Part 5 Sections 5 & 6). Where a ribbon is not provided for In Group classes at Championship Shows the value of the trophies shall not be less than the entry fee charged. Any individual cash trophy must be at least the cost of the entry fee charged.
- 235.2** **Other Disciplines**
The value of trophies for any other discipline shall not be less than the entry fee charged for first place and not less than 50% of the entry fee for second and third places. Any application for dispensation from this regulation that is made prior to the fixture will be considered by the TCA Inc Council.

PRESS RELEASE: AFGHAN HOUND SURVEY RESULTS



A survey was conducted by Dogs Australia last year to ascertain the feedback from all owners of registered Afghan Hounds in relation to the Minimum Breeding Age for Afghan Hound bitches being 24 months at the time of mating (unless a veterinary certificate is produced stating that for health reasons the bitch should be mated before 24 months).

The response received indicated support.

As this was an amendment to current regulations, the result of the survey was referred to the Dogs Australia Board of Directors for consideration at their February 2022 Special Board meeting where it was endorsed.

As a consequence, the following new clause will be added to Regulations Part 6 – The Register & Registration which will be effective from 1 July 2022:

8.16 Afghan Hound (Added 02/22 – 6.1. Effective 01/07/2022)

The Minimum Breeding Age for Afghan bitches is 24 months at the time of mating (unless a veterinary certificate is produced stating that for health reasons the bitch should be mated before 24 months).

Breeders of litters whelped on or after 1 June 2022 will be required to comply with the requirements as a prerequisite to registration of any litter on the ANKC Ltd Main Register. Litters which do not meet the above requirements will only be able to be placed on the Limited Register and will be flagged not to be upgraded.

DOGS AUSTRALIA SPECIAL BOARD MEETING



Held via Zoom Video Conferencing on 12 February 2022

At the February 2022 ANKC Ltd Special Board meeting, Directors resolved/considered the following:

1. * ANKC Ltd Regulations Part 5 – Conformation Shows

It was RESOLVED that Clauses 10.6.2 and 10.6.3 of ANKC Regulations Part 5 – Conformation Shows be amended to read:

10.6.2 Points shall be allotted for exhibits six (6) months of age and over exhibited in a Neuter Class as follows: **(Amended 02/22, 5.1 – Effective 01/07/22)**

a. **Neuter Certificate winner – Dogs and Bitches**

Five (5) points plus one (1) point for each Neutered dog of the breed over the age of six months exhibited at the fixture.

b. **Best of Neuter Certificate winner**

Five (5) points plus one (1) point for each neuter dog and bitch of the breed over the age of six months exhibited at the fixture.

c. **Best Neuter in Group winner**

Each winner of the recognized seven (7) groups or ten (10) at CACIB shows – five (5) points plus one (1) point for each Neuter dog and bitch over the age of six months and exhibited in the Group at the fixture.

d. **Runner up to Best Neuter in Group**

Each Runner Up in the recognized seven (7) groups or ten (10) at CACIB shows – ten (10) points less than the Best Neuter in Group Winner or breed points whichever is higher, with the minimum being six points.

e. **Best Neuter in Show winner**

Five (5) points plus one (1) point for each Neuter dog and bitch exhibited in the Show or breed points whichever is higher, with the minimum being six points.

f. **Runner up to Best Neuter in Show**

Ten (10) points less than the Best Neuter in Show Winner or breed points whichever is higher, with the minimum being six points.

10.6.3 The points awarded under (a), (b), (c), (d), (e) and (f) above shall not accumulate and shall, in no case, exceed twenty-five (25) points at any one Show.

Note: This amendment to the regulations will be effective 1 July 2022.

2. * ANKC Ltd Regulations Part 6 – The Register & Registration

It was RESOLVED that Regulations Part 6 – The Register & Registration be amended with the inclusion of new Clause 8.16 to read:

8.16 **Afghan Hound (Added 02/22 – 6.1)**

The Minimum Breeding Age for Afghan bitches is 24 months at the time of mating (unless a veterinary certificate is produced stating that for health reasons the bitch should be mated before 24 months).

The Minimum Breeding Age for Afghan Hound bitches, breeders of litters whelped on or after 1 June 2022, will be required to comply with the requirements as a prerequisite to registration of any litter on the ANKC Ltd Main

Register. Litters which do not meet the above requirements will only be able to be placed on the Limited Register and will be flagged not to be upgraded.

and the existing Clauses 8.16, 8.17 and 8.18 will be renumbered.

Note: This amendment to the regulations will be effective 1 July 2022.

3. * ANKC Ltd Regulations Part 13 – Regulations for the Conduct of National Breed Councils

It was RESOLVED that Regulations Part 13 – Regulations for the Conduct of National Breed Councils clauses 2.3.1 be amended to read:

2.3.1 The Membership of a National Breed Council must be comprised of at least two (2) Specialised Breed Clubs, each affiliated with a separate Member Body of the ANKC Ltd.

And the removal of Clause 2.3.2.

Note: This amendment to the regulations will be effective 1 July 2022.

4. Tenterfield Terrier – Extension to the Breed under Development

It was RESOLVED that the Tenterfield Terrier Breed under Development be extended for five years from 1 January 2022.

5. Recognition of the Sport of Canine Disc

It was RESOLVED that the agreement between Dogs Australia and Canine Disc Australia Ltd be endorsed in principle and for it to be referred to the National Legislative Committee for any necessary amendments in liaison with the Canine Disc Australia Ltd.

6. Breeders Terms Contracts

It was RESOLVED that all Member Bodies review the transfer of dogs in their state and territory in the context of breeders terms contracts and other guardianship arrangements and provide feedback to the October 2022 Board meeting; and for Dogs Australia to obtain legal advice from a legal specialist in the context of sale of goods/consumer protection legislation for distribution to Member Bodies.

Substitute Judges:

The affiliate conducting an exhibition reserves the right to substitute judges if the committee deems it necessary. Entry fees are not refundable – refer TCA Inc Regulation 227.

It is the exhibitor's responsibility to have his/her exhibit/s available for judging in all classes or events for which it is correctly entered and for the classes for which it subsequently becomes eligible – TCA Inc Regulation 33 + 33A.

I cannot remember a time in my life when I have not had a dog! My father loved Dachshunds and we always had, what seemed to be hundreds! of standard smooth Dachshunds when I was growing up. I was born in England but raised, married and had my children in Central Africa (Northern and Southern Rhodesia, now Zambia and Zimbabwe). I have also owned and exhibited a Standard Smooth Dachshund. I became an All Breeds judge in 2004. I have judged extensively throughout Australia, New Zealand and also South Africa, India, Indonesia, China and Canada.

I am an active member of Dogs SA being a member of the Investigations Committee and am on the Judges Training Panel for Group 6.

I am President of The Papillon Dog Club of South Australia Inc and Secretary of Canine Fanciers Kennel Club. I am a life member of The Adelaide Hills Kennel Club and Vice President of the Toy Dog Club of SA and a past Secretary of the Setter Club of South Australia.
