Luna the Keeshond was born 3 July 2014 in South Australia bred by Angela Misell and she arrived to our home and hearts at 8-weeks-old. I had never owned a dog prior to this and had no idea what I was doing at the time. I originally got Luna after 18 months of research trying to find a good medium sized dog to use as a therapy dog at my work. I was lucky enough to get the last pup of the litter. We joined Tas Dog Training Club soon after to ensure she had all her basic obedience and socialisation to help us achieve our therapy dog dreams. It was there that we discovered Rally through a beginner's course and after going from hopeless to hero heeling in those six weeks, we wanted to try it out officially. We had our first Rally trial in early 2016 and from there we were hooked on dog sports!

In 2018 we travelled to Melbourne and completed a week long course for accreditation as an Animal Assisted Therapy Dog team. In May 2018 Luna became the first dog working officially in the Tasmanian Health Service where she still works with me to this day.

Luna is very affectionate but opinionated girl, keeping to the spitz breed type, who likes to keep me honest and on my toes. She loves to do her sports and work with me, but is also very quick to tell me when she is done. True to her sporting nickname of "Prima-donna Princess Powder Puff"!

Over the years we continued our Rally journey, began Obedience, and really threw ourselves into agility/jumping achieving many titles over the years. There was always a goal to achieve Rally Champion which was hampered by COVID, health issues, and my pregnancy, however in July 2022 we have finally achieved our goal! Luna is one of the few Rally Champions in Tasmania, and she is the first Keeshond in Australia to achieve a sport champion title!

At 8-years-old we are still continuing our journey, with plans to continue working towards Masters Agility and Jumping titles along with preparing for Trick trials in the new year. A big thankyou to the amazing Tasmanian Dog Sports community who supported us through our journey. And of course, a massive thank you to my amazing Luna, I couldn't have asked for a better first canine companion and sport partner!

Responding to Activists

STEPS FOR HANDLING CONFRONTATION AT AN EXHIBITION OR EVENT

Proudly show our practices are best practice	Regardless of the risk of confrontation, every exhibitor should proudly uphold the standards expected of us as loving dog owners and members of Dogs Tasmania and present our dogs and ourselves positively.
Advise the show or trial manager, call 000 if needed	Advise the event manager if you believe activists are present and they will advise the local police. If activists create a disruption or confrontation, call 000 immediately. If you call 000 clearly articulate the risk that the activists are posing: to yourself and others, the dogs' welfare, personal and venue property, etc.
Do not engage	Do not engage directly. Keep calm even if provoked and keep your distance if possible.
Ask them to leave	If activists enter the area you are using to house your dogs, speak with them politely to ask them to leave. Acknowledge their right to state their opinions in a lawful manner but ask that they respect your right to continue to look after your dogs' welfare in a safe manner without distress. Ask them to please leave the area and move to a space away from the dogs. They may not respond to the request, but it will make it clear they do not have permission to be there. Do not engage with them further.
Move yourself and your dogs to a safer position	Your safety and welfare and that of your dogs comes first. If activists won't leave, relocate to an area that is safer for you and your dogs.
Create a record	Video footage and photos taken on your phone of the above can be used by police. If there has been damage to property record the details and if possible wait until police have examined the scene before touching anything. Please always consider the safety of yourself and dogs when confronted with activists.

NOTICE OF ELECTION FOR FOUR (4) TCA INC COUNCILLORS

An election shall be held to elect four (4) Councillors to take office for the period February, 2023 to February, 2026.

A member nominating for election as a Councillor is required to meet the eligibility criteria as defined hereunder. The Commitment Statement must be completed and signed on the nomination form.

No person shall be eligible for election or appointment or be elected or appointed pursuant to this Clause unless the person at the time of closing of nominations:

- (a) Is an ordinary, secondary, pensioner or life member of the TCA Inc and at least eighteen (18) years of age.
- (b) Has been a member of the TCA Inc, or an ANKC Ltd affiliated body, for a total of at least five (5) years up to and including the closing date for nominations.
- (c) Has served as a member of the Council or the Council of an ANKC Ltd affiliated body; OR has held an executive position on a body affiliated with the TCA Inc for a period or periods in total of not less than two (2) years; OR has held an executive position on a body affiliated with a member body of the ANKC Ltd for a period or periods in total of not less than two (2) years; OR has held an executive position on the committee of a body incorporated under the Act for a period or periods in total of not less than two (2) years, in addition to having held an executive position on a body affiliated with the TCA Inc or with a body affiliated with a member body of the ANKC Ltd, for a period or periods in total of not less than one (1) year.
- (d) Executive positions are those of President, Vice-President, Treasurer and Secretary.
- (e) "ordinary secondary, pensioner or life member", in relation to this notice, means an eligible member of at least 18 years of age, who is a resident of the state of Tasmania, whose membership of the TCA Inc is currently financial.

An eligible member of the TCA Inc may cast a vote for not more than four (4) candidates. The four (4) candidates who receive the highest number of votes shall be elected to the vacant positions for a three (3) year term **February 2023 to February 2026**. In the event of a tied vote for the last position the names of those candidates who receive the identical number of votes in the tie shall be subject to a simple draw and the winner of the draw shall be duly declared elected as a Councillor.

Nominations for elections shall be accepted only on the approved nomination form available on the Association's website or from the TCA Inc office and with all the particulars required thereon properly completed.

The nomination must be placed in a sealed envelope marked 'nomination form' and posted to the Returning Officer Locked Box 420 North Hobart Tasmania 7002 to be received at the Locked Box 420 not later than the closing time of 12 noon on Friday 28 October 2022.

Please ensure that you allow enough time for Australia Post to deliver your nomination.

The list of nominees shall be published in the December/January issue of the "TCA Inc Gazette", together with the rules, regulations and procedure for voting.

Nominees are invited to submit a photo and a short resume of their involvement in canine activities which will be published free of charge. ***The resume must accompany the nomination form, a photograph is optional.***

A nominee may appoint a person who is a current financial member, as defined in Clause 1 of the Rules for Election, to act as their scrutineer at the counting of votes.

Counting of votes cast in such election shall take place at Shop 2-3, 77 Chapel Street, Glenorchy, **on Monday 9 January 2023 commencing at 1.00 pm.**

PRESIDENT'S REPORT

Hi Everyone

The Spring Show season is upon us and no doubt everyone is looking forward to the Royals and accompanying specialties. Best of luck to those competing in these shows and the many discipline events which will be held in the next couple of months.

An ad appears in this gazette giving notice of the next election for TCA Councillors. Each Councillor has a 3-year term and each year, four Councillors' terms will end. This of course means that there will be an election for four Councillors. The retiring Councillors are eligible for re-election. If you meet the criteria, please give serious consideration to nominating.

At the last AGM, I advised that the TCA had met with the Animal Welfare Advisory Board where some concern was expressed that we did not seem to be policing our rules regarding the health and welfare of dogs as effectively as we could. Since then the Council has been evaluating how we may lift our game and the Council has decided in the first instance to appoint our own inspectors rather than using Council Inspectors as was originally proposed. Membership renewal forms will be amended so that members will give Dogs Tasmania the right to enter and inspect their premises. It is envisaged that, at this point of time, inspections will only affect breeders classed as commercial under the existing Animal Welfare (Dogs) Regulations.

The review of the Association's Regulations is now proceeding and good progress is being made. Hopefully this time we will actually get the job finished.

Brighton Council has advised that a Project Manager has been appointed and that, once they have settled into the position, they will be in contact with the TCA Inc office regarding 'the shed'. Once more information is available a notice will be posted on the Dogs Tasmania Members Only Facebook page to keep everyone up to date.

What is pleasing is that I have noticed that exhibitors at Pontville are now generally not parking alongside the "chook shed". With the alterations to the rest of the ground, this roadway is the main access to the back half of the ground and has to be clear for emergency vehicles. Thank you to those who have heeded our requests.

COVID restrictions have been eased but it is still very prevalent. Quite a few of our members have had it in the past few months. Please continue to take precautions such as social distancing and mask wearing in appropriate circumstances.

The Dogs Australia AGM will be held this month and one of the matters which will be discussed is the formalising of ramping requirements. The proposed list is on the ANKC website and any comments should be forwarded to our office for transmission to Dogs Australia.

FROM THE OFFICE

Members are advised that the TCA Inc office will be closed Thursday 20 (Royal Hobart Show Public Holiday) and Friday 21 October 2022 and will reopen at 10.00am Monday 24 October 2022.

Any members paying their membership via bank transfer are reminded that they still need to forward the signed Application for Membership Renewal to the TCA Inc office.

Dogs SA has advised that Mr S. Oh, Membership No 5100044281, has been suspended for a five year period, effective 16 September 2022.

Members attending TCA Inc sanctioned fixtures are reminded that they should comply with any requests given by the organisers relating to parking and their set up. Also, please be mindful of other exhibitors and remember that everyone has to work together at these events.

With the ANKC requirement that puppies be registered in the new owner's name at point of registration we have introduced a program that forwards a copy of each puppy's Certificate of Registration and Pedigree to the breeder. Any breeder requiring copies of the Certificates of Registration and Pedigree for litters registered after 1 October 2021 and prior to 14 July 2022 should advise the office, via e-mail, detailing their request.

SCENT WORK RULES REVIEW

The closing date for submissions to Dogs Tasmania for suggested changes to the Scent Work Rules is **Thursday, 15 December 2022.**

Submissions should include the following details:

- a) the current rule/regulation number and rule/regulation detail;
- b) the proposed amendment;
- c) a full rationale for the proposed amendment.
- c) list any current rules/regulations which could be affected as a result of a consequential change/s from a proposed new rule/regulation or an amended rule/regulation.

A meeting will be held in early 2023 – to discuss and put forward the submissions to Dogs Australia.

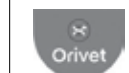

ATTENTION: ALL ROTTWEILER OWNERS

In accordance with the June 2022 Special Board meeting minutes an online survey is now available from the link provided below where Dogs Australia is seeking feedback from owners of Rottweilers regarding the following proposal.

Proposal:

To be added to Regulation Part 6, 8.17. Effective from 1/1/23 ALL Rottweilers be tested for JUVENILE LARYNGEAL PARALYSIS POLYNEUROPATHY (JLPP) prior to being mated and only Clear to Clear or Clear to Carrier be permitted. The exception to this is Frozen Semen whereby a sample can be taken from left over semen when a bitch is inseminated and then sent off for testing; in these cases the bitch must be a Clear on the chance the sire may be a Carrier. Certificate to be provided by the Laboratory carrying out testing eg: Laboklin, OFA, Orivet. Samples must be taken by a veterinarian or a Certified Collector.

Rationale:

Currently this only applies to members of state Rottweiler Clubs, but due to the horrific outcome for puppies where two carriers are still being mated by non club members we request **all** breeding pairs be tested. Over the past six years stats show an average of 19% of the Rottweiler population worldwide being tested are shown to be carriers. This is a recessive gene and can be controlled by selective breeding. Please read attached NRC(A) JLPP Scheme.

We refer to Dogs Australia Statement: **Dogs Australia registered breeders follow a strict code of ethics, conduct health checks and, for accountability, are supported by a database of inherited diseases – ORCHID.** We believe JLPP should be added.

BUSINESS ARISING FROM THE MINUTES:

Southern Venue

The EO advised that Mrs C Gangell, Mr D Strong and he had met with Brighton Council at Pontville to discuss the progress of the shed, that they had been advised that it was now with the Surveying Section of the Brighton Council and that once passed the pouring of the concrete slab would commence and that another meeting had been scheduled for 02 August 2022.

Calendar of Events

The EO advised the meeting that, at the June 2022 Council meeting, it had been agreed that a meeting of conformation clubs would be organised, via GoToMeetings, to discuss the Calendar of Events and suggested that a meeting of the performance based clubs to discuss the calendar needed to be organised as well.

FINANCE:

Financial Reports for the period 01 – 30 June 2022 were circulated to all Councillors indicating a loss of \$2314.85 for the period compared to a loss of \$8375.92 for the corresponding period in 2021 and a YTD profit of \$60196.59 compared to \$457774.29 for 2021 and Bank Registers for the same period showing a total of \$40783.75 in deposits and \$25373.27 in withdrawals.

COMMITTEE REPORTS:

OTEC – Track & Search Judges Training Scheme

A report from P Hallam advising that the trainee judges in the Association's Track & Search Judges Training Scheme needed training that could not be provided in Tasmania and suggested that the candidates be sent to Victoria 14 – 16 October 2022 to enable them to participate in the Dogs Victoria workshop was circulated to all Councillors.

GENERAL BUSINESS:

Executive Officer's Report

The EO's Report advised that:

- Processing was at a nine working day turnaround;
- There were 273 puppies registered in the period 8 June to 13 July 2022 compared to 331 for the same period last year, a total of 1555 for the year compared to 1615 in 2021;
- There were 1030 members including Life Members as at 13 July 2022 compared to 1009 in 2021;

Class in Show Certificates

S Axton advised the meeting that members were not happy with the format of the new ANKC Class in Show Certificates.

The EO advised the meeting that these certificates were produced for the ANKC and that all Member Bodies were using them.

Vendors at Shows

M Aitchison queried the public liability insurance requirement for vendors at TCA Inc sanctioned fixtures.

The EO advised that vendors had to have their own insurance as the Association's policy did not cover vendors, that it was up to the clubs giving approval for the vendors to operate at their fixtures to ensure that they did have a current policy and that, if they failed to do so the club could be held liable for any claims.

All exhibitions conducted by the Tasmanian Canine Association Inc and its affiliates are conducted under the rules and regulations of the Association, a copy of which may be inspected at the office of the event manager of the exhibition on the day of such exhibition.

The following rules/regulations apply to all exhibitions:

Financial Members:

A person 18 years of age and over and who is a resident of Tasmania may not exhibit, handle, officiate in the judging ring or register an animal unless he/she is a current financial member of the TCA Inc. A person seven years and under the age of eighteen years who handles a dog in the judging ring is required to be a junior member of the TCA Inc or a member of an affiliated club. At least one parent or guardian is required to be a financial member of the TCA Inc.

Entry fees must accompany the entry form and should be paid by cheque or money order (refer Australia Post regulation).

Substitute Judges:

The affiliate conducting an exhibition reserves the right to substitute judges if the committee deems it necessary. Entry fees are not refundable – refer TCA Inc Regulation 227.

It is the exhibitor's responsibility to have his/her exhibit/s available for judging in all classes or events for which it is correctly entered and for the classes for which it subsequently becomes eligible – TCA Inc Regulation 33 + 33A.
