#### **CONFORMATION JUDGES TRAINING**

Applications to join the 2023 Conformation Judges Training Scheme close Monday, 5 December 2022. *Late applications will not be considered*.

#### PERFORMANCE DISCIPLINES JUDGES TRAINING

Applications to enrol in Judges Training Schemes for Agility, Rally, Obedience, Field Trials, Tracking, Track and Search, Trick Dog, Herding, Endurance, Dance with Dogs, Earthdog or Lure Coursing should lodge an expression of interest with the TCA Inc office prior to Friday 16 December 2022. *Late applications will not be considered.* 

#### RALLY TITLES CLARIFICATION

An exhibit which has gained sufficient awards to qualify for the title of RN, RA, or RE shall NOT be eligible to compete in a higher class at a Rally Trial until such time as the owner/s have lodged an application for recognition of the title with Dogs Tasmania.

Once sufficient passes are gained and an application lodged for Rally Novice title you cannot go back and compete in Novice.

Once a dog has gained both Rally Advanced and Rally Excellent titles they may then enter both classes at the same trial to gain qualification for R.A.E. title – a minimum of five qualifying scores (80 pts or more) in both classes at the same trial.

#### TASMANIAN CONTEST OF CHAMPIONS

#### **REGULATIONS** effective 1 January 2020 for the 2023 Competition

- 1. This competition is organised by the Combined Breeds Dog Club of Tasmania Inc.
- 2. Any dog/bitch must have attained the title of Australian Champion by 31 December each year that is confirmed by the TCA Inc office prior to 15 January in the following year.
- 3. Each year the number of judges to be appointed shall be determined by the committee of the Combined Breeds Dog Club of Tasmania Inc.
- 4. The judges will be selected by an independent member on behalf of the committee of the Combined Breeds Dog Club of Tasmania Inc. The Judges will be announced on the night.
- 5. For dogs/bitches to compete at the Contest of Champions all qualifying points must be obtained at Tasmanian shows.
- 6. Dogs/bitches must gain their wins in Tasmania but do not have to be owned outright by a resident of Tasmania. Dogs/bitches, at the time of qualifying, wholly owned by a person/s not resident in Tasmania are ineligible.
- 7. There will be 32 invitations issued to the top qualifying dogs on the following basis: Invitations will be issued to the top 32 dogs ALL BREEDS

Scoring for these positions will be as follows:

Best in Show4 pointsRunner Up Best in Show3 PointsBest in Group2 PointsRunner Up In Group1 Point

(Maximum of 4 points per show)

- If any dog/bitch invited cancels, withdraws or does not accept the invitation an invitation will be issued to the next highest scoring exhibit.
- 8. Invitations will be forwarded to exhibitors as soon as possible but no later than 15 January in each year.
- 9. Judging will be by means of a knock out competition, 16 heats with the winner of each heat going through to the next round until two only remain. There will be one final winner. The order of judging will be determined by a public draw at the event prior to the commencement of judging.
- 10. The TCA Inc Council will appoint an independent adjudicator for the event.
- 11. In the event of any contingency arising which is not covered by these Regulations the club's committee, in conjunction with the TCA Inc appointed adjudicator, has the power to make such rulings as they determine are in the best interests of the club and the continuing prestige of the event.

# SUMMARY OF THE DOGS AUSTRALIA ANNUAL GENERAL MEETING & BOARD MEETING HELD IN SYDNEY ON 15<sup>TH</sup> OCTOBER 2022

At the recent Annual General Meeting of the Australian National Kennel Council Limited held in Sydney:

#### 1. Election of ANKC Ltd Executive

- Ms Pam Campbell was elected unopposed as Vice President for a one-year term from 15 October 2022.
- Mr David Sales was re-elected unopposed as Treasurer for a one-year term from 15 October 2022.
- Mrs Ulla Greenwood was elected as a member of the Executive Committee for a oneyear term from 15 October 2022.

At the October 2022 Dogs Australia Board meeting, Directors resolved/considered the following:

#### 1. Ramp Use Policy

Earlier this year Dogs Australia requested feedback from members as to the suitability of a proposed ramp breed listing as a proposed definitive list of breeds which may or may not be ramped or tabled.

The Board has made no final decision at this time in relation a Ramp Use Policy and has referred the matter to the National Breed Standards Coordination Group to review the submissions received from members and the Board will consider the matter again next year.

#### 2. \*Regulations Part 5 – Conformation Shows: New Clause 2.3.7

It was agreed for the following Infectious Diseases or Viruses regulation endorsed at the February 2022 Special Board meeting to be added to Regulations Part 5 – Conformation Shows as Clause 2.3.7 and will be effective from 1 January 2023. Infectious Diseases or Viruses

- a) If a dog has been in a kennel or premises affected with distemper, canine hepatitis, parvovirus or any other virulent contagious disease (except Kennel Cough), it shall not be permitted to attend any State Member Body event or grounds for a period of 12 weeks from the date of the first diagnosis or onset of symptoms.
- b) If a dog has been in a kennel or premises affected with or diagnosed with Canine Cough (also referred to as Kennel Cough or Canine Infectious Respiratory Disease Complex) it shall not be permitted to attend any State Member Body event or grounds for a period of three weeks after the date of the first diagnosis or onset of symptoms.
- c) An event organiser or affiliate official may ask for a dog to be immediately removed from any State Member Body event or grounds if that dog is visibly unwell or showing symptoms of the contagious diseases listed in (a) or (b). This shall be recorded in the Representative's report.

#### 3. Regulations Part 5 – Conformation Shows: Amendment to Section 4.1

It was resolved that Regulations Part 5 – Section 1 – Definitions and Classes Regulation 1.1.7 that

Currently reads:

#### 1.1.7 Definitions and Classes

Proprietary Interest – means having some legal or equitable interest in an animal on an on-going basis or the breeder of the exhibit. For the purposes of these Regulations the definition does not include using a Judge's stud dog or boarding a dog at a Judge's boarding kennel.

Be deleted.

AND for Section 4.1 Proprietary Interest to be amended as follows.

Section 4.1 Proprietary **Ownership** Interest as follows:

4.1.2 A person may not enter, exhibit or handle under a judge officiating at a conformation show where:

# RETRIEVING & FIELD TRIAL "HALL OF FAME" 2023 Nominations

In the first 20 years of elections, Dogs Australia has received nominations for 57 dogs and 43 people to be considered for induction into the Retrieving & Field Trial Hall of Fame. From the nominations received 35 outstanding dogs and 26 exceptional people have been inducted.

The criteria for the two categories for selection are the following:

- 1. **Outstanding Gundogs** (must be permanently retired from further competition and have not competed in the last 12 months, or be deceased):
  - (a) Their record as a winning dog i.e., CLUB STAKE DATE JUDGE PLACE and/or

(b) Their production record.

- (c) The eligibility for a dog should be based on its entire competitive career and previous record as a producer, not merely for a particular win or for a heroic deed within the field and retrieving trial sphere.
- (d) Subject to the receipt of a formal application, dogs that have been awarded the title of Grand Champion and have gained a total number of points equal to, or greater than, twice the total number required for that award, shall automatically be inducted into the Hall of Fame. Such applications must include full particulars and a brief resume of the dog's career.
- (e) Subject to the receipt of a formal application, dogs winning at least two National Championships in the same discipline shall automatically be inducted into the Hall of Fame. Such applications must include full particulars and a brief resume of the dog's career.

#### 2. Prominent Persons

Their record of a broad combination of accomplishments as:

- (a) Club Official
- (b) Judge
- (c) Owner
- (d) Handler

The distinction of nomination should be accorded to those who have made outstanding contributions to the field or retrieving game. Nominees should be **givers** to the sport and not **takers**.

Nominations are now being called for the current year. In addition to applications submitted in relation to Outstanding Gundogs 1(d) and 1(e), a maximum of two other outstanding gundogs and two prominent persons may be elected each year.

#### **Nomination:**

- Clubs or Members shall nominate DOGS and PEOPLE considered worthy of awards, including full details of accomplishments within the above categories and with verification. In the case of dogs, nominations should include the full name, title, owner and date of birth.
  - (Please note it is a condition of nomination that the nominator/s provides accurate written material supporting the nomination. In the absence of such accurate supporting material, or should the supporting material later prove to be inaccurate in areas of significance, the Selection Panel for the Dogs Australia Retrieving & Field Trial Hall of Fame reserves the right to reconsider its decision and if appropriate, delete the name of the Prominent Person or Distinguished Dog from the list of inductees.)
- Nominations shall close on 31 May, 2023 at the respective Member Body offices for forwarding to Dogs Australia.

- 2. All exhibits have to be in exhibitors name or co-owned/leased by an exhibitor who is a financial member of Dogs Tasmania at the time of the dog's win.
- 3. Puppies can qualify two years in a row but if same exhibit has won the POTY in the previous year it will be ineligible.
- 4. Competition will be held in February/March each year.
- 5. Invitation will be extended via the December issue of *The Gazette*.
- 6. Depending on entries received each dog will be entered in a heat of up to a maximum of five dogs, with two heats making up one round.
- 7. There will be two judges and each dog will be assessed by each judge in each heat of the round.
- 8. Dogs once handed over to the respective judge must compete and be assessed in both heats of the round.
- 9. There will be one winner from each heat that progress through to the next round.
- 10. There will be an outright winner only, no runner-up.

- a. The person is a member of the judge's family and/or resides at the same address as the judge.
- b. The judge has or has had any proprietary ownership interest in a dog or dogs solely or in partnership with the member within a period of 12 months prior to the conformation show.
- c. Where the judge has handled any dog owned, leased or part leased by the person within a period of 12 months prior to the conformation show.
- d. The person has handled any dog owned or part owned or leased, or part leased by the judge in a period of 12 months prior to the conformation show. The person has accommodated the judge or been accommodated by the judge within a period of 12 months prior to the conformation show or intends to accommodate the judge within 24 hours after the conformation show.
- e. The judge has trained or groomed for reward, for gift or favour a dog owned, or part owned, leased or part leased by the person in a period of 12 months prior to the conformation show.
- f. The dog was bred by the judge or the judge's family.
- g. For the purposes of these Regulations the definition "handled" does not include any circumstance where a person has assisted another exhibitor who, due to a judging decision on the day, was required to compete with two or more exhibits at the same time.
- h. Either the exhibitor or the judge has used a stud dog belonging to the other within the last six months.

This amendment will be effective from 1 January 2023.

# 4. \*Regulations Part 9 – Regulations for Non-Resident Judges

At the February 2022 Special Board meeting the submission received from Dogs West was endorsed pursuant to a review of the compilation of the 70% requirement for group status and clarification to ensure all late applications are considered by the Overseas Judges Approval Board.

It was resolved that the submission providing a revision of the 70% requirement of breeds for Group approval was endorsed.

These amended regulations will be effective from 1 January 2023.
