# TCA PRESIDENT'S REPORT

# FOR ANNUAL GENERAL MEETING OF MEMBERS MONDAY 13 MARCH 2023

As a preamble to my report, I would like to apologise for my absence at today's meeting. A commitment, which I could not postpone has taken me out of Hobart. I am sure in my absence the Vice President will ensure the smooth running of the meeting.

Well, that was the year that was, 2022 has come and gone and we have survived. In terms of our calendar, we were almost back to normal, however the Show Secretary's job suddenly became the most precarious on the Club Committee with judges cancelling because of Covid and airlines cancelling flights with little prior warning.

Regardless of the discipline, I think we should thank all those Show Secretaries who spent their Friday's nervously listening for the phone and hoping that it didn't ring. Then spending literally hours on the phone trying to arrange substitute judges. Many thanks also to the many local judges who stepped in to ensure the events went ahead.

Financially the association has had a good year. The Treasurer will report a substantial surplus despite the additional costs in having our own dedicated premises. I am sure everyone will study the financial statements closely.

The move of the office to new premises has run smoothly. The office space really matches our needs and the meeting room has been a bonus. The Library Custodians have been working assiduously cataloguing our stock and culling unwanted items. Cupboards have been purchased and all books are safely stowed and access can be arranged by contacting the office. Thanks to the custodians for the great effort in achieving this. In addition, some clubs are using the room for meetings and it has been a valued base in Hobart for Zoom meetings.

Now that the Constitution has been reviewed and amended a small working group has been trying to get the regulations into some semblance of order. This is a really major job as anyone who has tried to find something in the regulations will attest. The job may be completed this year but I expect it will probably be early next year.

The Pontville Sports Centre has been working well as the Hobart base for conformation shows. Obviously the greatest disappointment has been the extraordinarily slow progress on the indoor facility. There are actually some signs of action on the project, and I hope we can report its opening during 2023 in next year's report.

While conformation entries are down again, the shining light has been the number of new disciplines which have emerged. I see these activities as the future of canine activities and it is great to see the increasing representation of participants in these activities on the Dogs Tasmania Board.

Although the number of candidates was small, congratulations to the two candidates who passed their conformation judges licence exams and congratulations to all the participants in other disciplines who were also successful.

We have also been talking to an interstate Compliance Officer regarding the introduction of a compliance scheme in Tasmania. At our meeting with the Animal Welfare Advisory Committee, it was pointed out to us that while AWAC was generally satisfied with our legislative structure, unless satisfactory compliance procedures were being pursued more onerous legislation may be required. Regulations are being prepared and should be implemented in the middle of the year.

On the national scene, Dogs Australia has rebranded itself and commenced a publicity

campaign to cement its place as Australia's principal canine organisation. To distinguish ourselves, Dogs Australia will continue to emphasis the quality of our breeders and the numerous measures that our breeders take to secure the health and welfare of the puppies they breed.

Gradually the whole administrative process is becoming electronic. We have allowed the larger states to test some of the systems so that when we transfer, the bugs will be ironed out but the changes will continue to be rolled out.

We also now have a new title to strive for. A suite of AAOS Championships will be able to be obtained at A20 Shows. Details of the requirements will be released by Dogs Australia in the near future. In addition, there have been changes for CACIB Shows. A new class of Veteran has been introduced as compulsory and CACs will be available for Juniors and Veterans and they can achieve CAC-J or CAC-V titles.

All of the ANKC Committees have a Tasmanian Representative and I would like to thank our highly qualified members who give up their valuable time to participate. I have been Treasurer of ANKC for many years and can report it is in a very sound financial position despite spending money to raise our profile. During the year with the assistance of most states, ANKC contributed \$40,000 to the FCI's fund to assist canines affected by the war in Ukraine. We are currently looking to assist with the problems in New Zealand, as they contributed to our fundraising following the fires in Victoria.

Dogs Australia is looking to progress health testing in a number of areas and gradually this information is being transferred into the registration system and in many cases is being made mandatory for registration.

I have thanked a number of groups, in this report but in case I have missed anybody sincere thanks to all our volunteers. They give enormous amounts of their own time to enable our activities to continue. If we had to pay for the work they do, we would not have a sport.

In conclusion I would like to thank all Councillors for the work they too have put in during year and the great support they have given me. I would also on behalf of members thank Tull Luttrell for her efforts while on Council and welcome David Strong to Council It would also be remiss not to acknowledge the sterling efforts of Kerry, Judy and Debbie during 2022. The result is a credit to them. I think we should also acknowledge the additional tasks they have taken on in the move to Pontville and which will continue until we have our "shed". This certainly is not part of their job description and the time put in outside normal office hours is considerable.

- 20B Proprietary interest is defined as having owned, part owned, leased, part leased or bred the exhibit.
- 180A No person shall enter or exhibit a dog in any sanctioned conformation exhibition (Open Shows or Parades exempt) at which a judge who is a member of the competitor's immediate family or who resides at the same address or who has had a proprietary interest in such dog whether solely or in partnership is scheduled to officiate.

# SUMMARY OF THE DOGS AUSTRALIA SPECIAL BOARD MEETING HELD VIA ZOOM VIDEO CONFERENCING 11 FEBRUARY 2023

At the February 2023 Dogs Australia Special Board meeting, Directors resolved/considered the following:

\* Dogs Australia Code of Practice of Responsible Dog Ownership
 It was RESOLVED that Clause 13 of Dogs Australia Code of Practice of Responsible Dog
 Ownership be amended to read:

13. Subject to the legislation in the relevant State of Territory, a member shall not breed a bitch causing it to whelp more than twice in eighteen months.

Note: This amendment to the Code of Practice will be effective 1 July 2023.

- 2. \* Dogs Australia Regulations Part 5 Conformation Shows, Clause 2.4.2 Removal It was RESOLVED that the following Clause 2.4.2 be removed from Regulations Part 5 – Conformation Shows:
  - 2.4.2 Catalogues are not to be made available prior to one hour before the advertised start time of a conformation show. Royal shows and cluster shows catalogues may be released one hour prior to the first day or first show.

Note: This amendment to the regulations will be effective 1 July 2023.

- 3. \* Dogs Australia Regulations Part 5 Conformation Shows, Section 9 Amendment It was RESOLVED that Section 9, Clauses 9.3, 9.6, 9.7, 9.9.3 and 9.9.4 of Regulations Part 5 Conformation Shows be amended to read:
  - 9.3.1 Applications to hold a CACIB International Dog Show sanctioned by ANKC Ltd, and subsequently by the FCI, must be sent in the first instance to the Member Body of ANKC Ltd where the show is planned to be held no later than 18 months prior to the intended show date and, if the application is supported by that Member Body, is then to be forwarded to ANKC Ltd for consideration. If approved by ANKC Ltd the application is then to be forwarded to the General Secretariat of the FCI no later than 12 months prior, and no earlier than four calendar years prior, to the proposed date of the show. Applications must be accompanied by the Application Fee. The application fee will be refunded if the application is not approved.
  - 9.6 Unclassified Breeds not recognized by the FCI (Not eligible for CACIB)
     9.6.1 Breeds not definitively recognised by the FCI may be awarded an Australian Challenge (Best of Breed). A schedule of these breeds will be maintained on the Dogs Australia Website.
  - 9.7.1 Only the following classes are recognized at ANKC/CACIB shows sanctioned by the FCI:
  - a. Classes ineligible for the CACIB:
    - Baby Puppy
       Minor Puppy
       Puppy
       For dogs aged three and under six months.
       For dogs aged six and under nine months.
       For dogs aged six and under twelve months.
    - 4) Veteran For dogs aged eight years and over.
  - b. Classes eligible for the CACIB:
    - Junior For dogs aged nine and under eighteen months (providing the winner is over 15 months of age).

2) **Intermediate** 

3) Open

4) Champion

For dogs aged eighteen and under thirty-six months. For dogs 15 months and over that are not Champions.

To enter a dog in Champion Class, the title must have been confirmed by the issue of a Registered Pedigree Certificate with the title added by the day of the official closing date of entries. Note: A Champion that has not attained 15 months of age may not be awarded a CACIB.

c. Class in which the FCI-CACIB-J can be awarded:

a. Junior For dogs aged nine to less than eighteen months.

d. Class in which the FCI-CACIB-V can be awarded:

a. Veteran For dogs aged eight years and over.

No other classes may be offered at CACIB Shows.

Removal of Clauses 9.9.3.3. and 9.9.4.3 which currently read:

9.9.3.3 Baby Puppy and Puppy in Group Awards may be offered. No other Class in Group Awards may be offered.

9.9.4.3 Baby Puppy and Puppy in Show Awards may be offered. No other Class in Show Awards may be offered.

Note: These amendments to the regulations will be effective 1 July 2023.

# 4. \* Dogs Australia Regulations Part 5 – Conformation Shows – Addition of New Section 9A

It was RESOLVED that a new Section 9A pertaining to the Conduct of FCI – Asia, Africa and Oceania Section (AAOS) A20 Shows be added to Regulations Part 5 – Conformation Shows

Note: This amendment to the regulations will be effective 1 July 2023.

#### 5. \* Dogs Australia Regulations Part 6 – The Register & Registration

It was RESOLVED that Regulations Part 6 – The Register & Registration be amended with the inclusion of new Clause 8.17.2 to read:

8.17.2 Effective from 01/01/23 ALL Rottweilers be tested for JUVENILE LARYNGEAL PARALYSIS POLYNEUROPATHY (JLPP) prior to being mated and only Clear to Clear or Clear to Carrier be permitted. The exception to this is Frozen Semen whereby a sample can be taken from left over semen when a bitch is inseminated and then sent off for testing; in these cases the bitch must be a Clear on the chance the sire may be a Carrier. Certificate to be provided by the Laboratory carrying out testing eg: Laboklin, OFA, Orivet. Samples must be taken by a Vet or a Certified Collector.

#### 6. Acknowledgement of Endorsement – Certified Pedigree

It was RESOLVED that the requirement for the new register owner/s to sign the declaration on the application to transfer registered ownership of dog be amended to make it clear that the new registered owner has accepted the breeder's sale conditions.

Further that both endorsements be displayed into separate boxes with a declaration for each endorsement.

Note: This amendment to the Certified Pedigree will be effective 1 July 2023.

#### 7. Fast Cat Sprint Dog Working Party Formed

It was RESOLVED that a Working Party be formed comprising of one member from each state/territory to investigate the possibility and viability of a sport called "Fast Cat" or called "Sprint Dog" in conjunction with Lure Coursing.

#### 8. Judges' Contracts – Emergency Contact

It was RESOLVED that a section for an emergency contact be included on all ANKC Judges' Contracts.

Note: This amendment to the Judges' Contract will be effective 1 July 2023.

# PRESS RELEASE EHRLICHIOSIS IN DOGS



#### Distribution of the Brown tick in Australia

Currently as of early 2023, the disease has been reported in the Mount Isa area and as far east as Townsville.

All people travelling with dogs into north Queensland, the Northern Territory, the far north of Western Australia and northern South Australia should be taking precautions against ticks.

All dogs should have Serresto tick collars on prior to entering these areas and to stay on tick preventatives for several weeks following. If you are using other oral products for flea, heart worm and tick control, these can continue to be used. The aim is to prevent the tick from biting the dog and these collars repel the ticks.

Ehrlichiosis is a tick-borne disease affecting primarily dogs but equally affects dingoes and foxes. It is not transmitted from dog to dog, transmission only occurs through infected ticks, the main one being the brown dog tick.

The brown dog tick is widespread throughout mainland Australia. No brown ticks have been found in Tasmania. While some ticks are mostly coastal, the brown dog tick is found extensively throughout the Australian continent.

*Ehrlichiosis is the disease* that is caused by a tick-borne bacteria called Ehrlichia Canis. Once a dog has been bitten by an infected tick, there are three stages of infection:—

- 1. Acute or early phase (3-4 weeks)
- 2. A subclinical phase (months to years)
- 3. Chronic or long-term stage (months to years)

Symptoms include fever, lethargy, enlarged lymph nodes, loss of appetite, discharge from the eyes and nose, weight loss, anaemia, and bleeding disorders such as nosebleeds or bleeding under the skin that looks like small spots, patches or bruising.

The severity of symptoms varies considerably between dogs. The incubation period is 1–3 weeks after the tick bite, but the chronic form may not manifest for months or years following infection. PCR and ELISA tests give the most accurate diagnosis along with comprehensive blood tests. Affected dogs require veterinary treatment and supportive care, the earlier this is diagnosed and treated the better. Usually, these dogs are treated with tetracycline drugs for a minimum of four weeks, shorter treatment periods may result in subclinical carriers. Seronegative PCR tests will indicate if the infection has cleared.

If not properly treated these dogs can and do die.

#### Distribution

This disease can be found worldwide, particularly in tropical and subtropical areas. Once the disease is in the brown dog tick population, it is very difficult to control. German Shepherds and Siberian Huskies are predisposed to develop more severe signs of disease with a worse prognosis (reduced cell-mediated immune response). In extremely rare cases, infected ticks may infect people, however the species of Ehrlichia that affects humans have not yet been detected in Australia.

Ehrlichiosis is currently a notifiable disease. While this disease was first reported in the far north of Western Australia in the middle of 2020. Since that time, cases have also been found throughout the Northern Territory where it is now considered endemic, right down to the South Australian border. A case has been found recently in Mount Isa where the infected dog has no history of ever leaving the state.

At the rate this is moving, no state will be safe and all people who travel with their dogs should be aware of the risks and the need to provide preventative measures to protect their dogs.

Dogs from affected areas are being monitored and their movement limited (at this stage). Dogs (including rescue dogs) moving out from these areas are required to test negative. Healthy dogs should be on an effective tick control program.

#### Prevention

The aim is to prevent tick bites in the first place so as to avoid the dog getting the disease. The best prevention is to use Tick collars of which Serresto is the best as it repels ticks.

Secondly, have a good tick and flea control program in place so that if a tick does get on the dog, it will be killed. There are quite a few products that can be used but ensure the dog is not left unprotected by running late with treatments.

Avoid taking dogs into tick infected areas such as bush and long grass, particularly in coastal areas. Inspect your dogs daily for ticks for 5–6 days after being in tick infected areas.

Check bedding and treat with anti-parasite sprays if in a tick area.

#### **Travelling**

The most likely way this disease will spread is by the transport of dogs interstate. Dog exhibitors like to travel far and wide for shows, often interstate. We should all be vigilant with providing tick control measures and renewing these before we travel!

Do not take dogs running along beaches, through the bush etc without adequate tick prevention. Be aware at some shows, the grounds may back onto bush, do not walk your dogs through these areas.

#### **Long Term**

At the rate this disease Is spreading, it is highly likely that this disease will be widespread throughout Australia within the next 5–10 years. With global warming, the brown ticks will become more common even in the southern states. Keep an eye on warnings put out by the government of where new cases are detected so you can be aware of this real threat to your dogs health.

Tick prevention should become second nature, especially when travelling into areas of high risk.


