8. ELIGIBILITY TO NOMINATE FOR ELECTION

- 8.1 No person shall be eligible for election or appointment, or be elected or appointed pursuant to this Clause, unless the person at the time of closing of nominations:
 - 8.1.1 Is an ordinary, secondary, pensioner or life member of the TCA and at least eighteen (18) years of age.
 - 8.1.2 Has been a member of the TCA, or an ANKC affiliated body, for a total of at least five (5) years up to and including the closing date for nominations.
 - 8.1.3 Has served as a member of the Council or the Council of an ANKC affiliated body; OR
 - 8.1.3.1 has held an executive position on a body affiliated with the TCA for a period or periods in total of not less than two (2) years; OR
 - 8.1.3.2 has held an executive position on a body affiliated with a member body of the ANKC for a period or periods in total of not less than two (2) years; OR
 - 8.1.3.3 has held an executive position on the committee of a body incorporated under the Act for a period or periods in total of not less than two (2) years, in addition to having held an executive position on a body affiliated with the TCA or with a body affiliated with a member body of the ANKC, for a period or periods in total of not less than one (1) year.
