### NOTICE OF ELECTION FOR FOUR (4) TCA INC COUNCILLORS

An election shall be held to elect four (4) Councillors to take office for the period February, 2024 to February, 2027.

A member nominating for election as a Councillor is required to meet the eligibility criteria as defined hereunder. The Commitment Statement must be completed and signed on the nomination form.

No person shall be eligible for election or appointment or be elected or appointed pursuant to this Clause unless the person at the time of closing of nominations:

- (a) Is an ordinary, secondary, pensioner or life member of the TCA Inc and at least eighteen (18) years of age.
- (b) Has been a member of the TCA Inc, or an ANKC Ltd affiliated body, for a total of at least five (5) years up to and including the closing date for nominations.
- (c) Has served as a member of the Council or the Council of an ANKC Ltd affiliated body; OR has held an executive position on a body affiliated with the TCA Inc for a period or periods in total of not less than two (2) years; OR has held an executive position on a body affiliated with a member body of the ANKC Ltd for a period or periods in total of not less than two (2) years; OR has held an executive position on the committee of a body incorporated under the Act for a period or periods in total of not less than two (2) years, in addition to having held an executive position on a body affiliated with the TCA Inc or with a body affiliated with a member body of the ANKC Ltd, for a period or periods in total of not less than one (1) year.
- (d) Executive positions are those of President, Vice-President, Treasurer and Secretary.
- (e) "Ordinary secondary, pensioner or life member", in relation to this notice, means an eligible member of at least 18 years of age, who is a resident of the state of Tasmania, whose membership of the TCA Inc is currently financial.

An eligible member of the TCA Inc may cast a vote for not more than four (4) candidates. The four (4) candidates who receive the highest number of votes shall be elected to the vacant positions for a three (3) year term **February 2024 to February 2027**. In the event of a tied vote for the last position the names of those candidates who receive the identical number of votes in the tie shall be subject to a simple draw and the winner of the draw shall be duly declared elected as a Councillor.

Nominations for elections shall be accepted only on the approved nomination form available on the Association's website or from the TCA Inc office and with all the particulars required thereon properly completed.

The nomination must be placed in a sealed envelope marked 'nomination form' and posted to the Returning Officer Locked Box 420 North Hobart Tasmania 7002 to be received at the Locked Box not later than the closing time of 12 noon on Tuesday 31 October 2023.

Please ensure that you allow enough time for Australia Post to deliver your nomination.

The list of nominees shall be published in the December/January issue of the "TCA Inc Gazette", together with the rules, regulations and procedure for voting.

Nominees are invited to submit a photo and a short resume of their involvement in canine activities which will be published free of charge. *The resume must accompany the nomination form, a photograph is optional.* 

A nominee may appoint a person who is a current financial member, as defined in Clause 1 of the Rules for Election, to act as their scrutineer at the counting of votes.

Counting of votes cast in such election shall take place at Shop 2–3, 77 Chapel Street, Glenorchy, on Monday 8 January 2024 commencing at 1.00 pm.

Hi Everyone,

Well, the last couple of messages have started off with the "No News" with regard to the shed at Pontville. As most of you are aware from our Face Book page work has actually started and I called in this morning (Thursday 28th September) and the first wall was just being finished. I don't know if it will be finished in time for the Brighton Show but it certainly should be ready for the next club shows in January 2024. Perhaps I can now drop this off my list for future columns.

This edition also includes details of the election for Council members for 2024–27. Four members are retiring and three are eligible for re-election. If you are interested in becoming a Councillor, have a look at the requirements and if you are eligible, get a nomination form, fill it in and get it back by the closing date.

The ANKC AGM and Board meeting is coming up later this month and there are number of issues that will be discussed such as compulsory DNA testing for parentage and treating docked dogs the same as dogs with cropped ears. Our Council has yet to formulate its views on these issues as well as the many other matters listed on the agenda.

The new ramping regulations come into effect from 1 January 2024, although there is a proposal on the ANKC Agenda to defer implementation. It is important that clubs, judges, exhibitors and most importantly stewards understand the requirements. The regulation has now been posted on the Dogs Australia website.

DogsTas has yet to finalise its policy on kennel inspections. When it is finalised, it will be published so everyone can see what will happen. The one thing I think I can say with certainty, is that there will be no surprise raids. All inspections will be done by appointment.

It's "Royal" month and no doubt we will have a number of interstate visitors. If you have entered, I wish you every success but, more importantly have a great day.

There are reports of kennel cough in the dogs and influenza and Covid in humans. Please take all necessary precautions for both your own and you dogs' health.



- 6. Presentations will be made at a fixture.
- 7. The TCA Inc Council's decision is final. No correspondence will be entered into under any circumstances.
- 8. No serving Councillor will be eligible for this award.

# Rules for the Conduct of Agility Trials and Agility Games Original Rule 7.2 reinstated

ATTENTION: ALL MEMBER BODIES

In 2020 Rule 7.2 in the Rules for the Conduct of Agility Trials and Agility Games was temporarily modified to safeguard Trial officials against the transmission of COVID. The states and territory governments are now free from any COVID restrictions which makes this rule modification redundant. The National Agility Committee members have agreed the temporary rule is no longer required and the original Rule 7.2 should be reinstated effective immediately.

Please be advised that the temporary rule that was mandated in 2020 is now unnecessary and we ask that you revert to the original Rule 7.2 in the Rule Book as noted below. Should a future restriction be put in force in any state or territory, that Member Body may reinstate the COVID modification until such time as the restriction is lifted without referring to Dogs Australia for approval.

7.2. Entering and Exiting the Ring

On the Steward's call of the dog's catalogue number, the Handler will enter the ring via the entry point, with the dog on lead either carried or walked and follow the Steward's and/or Judge's instructions. The lead and harness or head collar must be removed, the collar may be removed and all items handed to a Steward or may be placed on the ground behind or in a provided nearby receptacle. The steward will remove items after the dog/handler team commences their run.

For information purposes only please find below a copy of the temporary modified rule: 7.2 On the Steward's call of the dog's catalogue number, the Handler will enter the ring via the entry point, with the dog on lead and follow the Steward's and/or Judge's instructions. The lead will be removed, the collar may be removed. The Handler will either place the lead/collar in a pocket whilst running the course or wear it on them (e.g. clipped around their waist like a belt). If any of these items fall to the ground or the dog grabs the lead while running the course this will result in a DQ. The lead/collar must be inaudible and if not this will result in a DQ.

### **CODE OF BEHAVIOUR AND ETHICS**

### PART 1 - BEHAVIOUR

- 1. A member of the Tasmanian Canine Association (TCA Inc.) at all times
  - shall conduct themselves politely and with integrity at any TCA Inc. approved event;
     and
  - shall conduct themselves in a sportsmanlike manner at such events and in any related activities or communications; and
  - (c) shall respect the reputations of other members, all judges and officials, at TCA Inc. approved events and in dealings in wider forums, including chat lists, on the internet and in other communications; and
  - shall not engage in any behaviour that is contrary to the standards accepted by the community
  - (e) shall display good sportsmanship and conduct at all times so as to reflect credit upon themselves, the Australian National Kennel Club (ANKC Ltd) and the TCA Inc.

### PART 2 – COMPLIANCE WITH CODE OF ETHICS

- 2. (1) Each person, upon signing an application for membership or renewal of membership of the TCA Inc., and being duly elected to general membership of the TCA Inc., in addition to agreeing to be bound by the Constitution, and Regulations of the TCA Inc., shall also agree to be bound by the TCA Inc.'s Code of Behaviour and Ethics.
  - (2) Any failure to comply with this Code of Behaviour and Ethics will lead to disciplinary action which may result in loss or suspension of membership or other penalty.

### PART 3- CODE OF ETHICS BREEDING AND UNDERTAKING

- A member shall not knowingly or recklessly misrepresent the ANKC Ltd or the TCA Inc., trading as Dogs Tasmania.
- 4. A member shall constantly strive to improve their knowledge of their chosen breed or breeds, and their knowledge of the requirements for the care, welfare and betterment of dogs.
- 5. (1) A member shall ensure that all dogs under their control are properly controlled, housed, fed, watered, exercised at all times and receive veterinary care as required in accordance with any Government Regulations.
  - (2) All dogs shall be able to stand up to full height and be able to turn around with ease in any crate in which it is confined.
  - (3) A Member shall ensure that dogs under their control are not left in any situation that may cause injury or death to the dog.
- **6.** A member who leaves his or her dog in the care of another person remains ultimately responsible for that dog.
- 7. A member shall take all appropriate lawful measures to assist a dog in distress.
- **8.** A member shall positively enhance the reputation of dog breeders and owners by ensuring that dogs owned by the member are not a danger or nuisance to the community.
- **9.** A member shall not participate in, nor support, any activity that involves cruelty or damage to animals, other than a legal hunting activity.
- **10.** A member shall not dispose of any dog owned or bred by the member to a pound or animal refuge.
- **11.** A member shall breed primarily for the purpose of improving the quality, health, welfare, soundness or working ability of the breed in accordance with the breed standard, and not specifically for the pet or commercial market.
- 12. A member shall not mate a bitch before it is 12 months of age unless the bitch is of a breed that has Litter Registration Limitations regarding age as set out in Part 6 of the ANKC Regulations.

- **13.** Except in extenuating circumstances, a member shall not cause or allow a bitch to whelp more than twice in 18 months without the prior approval of the TCA Inc.
- 14. Except in extenuating circumstances, a member shall not cause or allow a bitch to whelp more than six times without
  - (a) prior veterinary certification of fitness for further breeding; and
  - **(b)** prior approval of TCA Inc.
- **15.** (1) A member shall not, without the prior approval of TCA Inc., permit any of that member's pure bred dogs to be mated to
  - (a) a dog of a different breed; or
  - **(b)** a cross bred dog; or
  - (c) an unregistered dog of the same breed; or
  - (d) a dog that is not on the Main Register.
  - (e) a dog that will result in a litter that cannot be registered with the ANKC.
  - (2) A member shall only be allowed to breed ANKC Ltd recognized pedigree dogs unless the breed concerned is on the ANKC development register and with the prior approval of TCA Inc. Special dispensation may be given for members who breed dogs on the Sporting Register upon application to the TCA Inc Council.'
- **16.** A member shall take all reasonable action to reduce the incidence of hereditary diseases in accordance with the ANKC Ltd Code of Practice for Hereditary Diseases.
- 17. A member shall not sell or otherwise transfer from his or her care any puppy under eight [8] weeks of age.
- **18.** A member shall not export a puppy under eleven [11] weeks of age, or any greater age as may be specified under the livestock import requirements of the country to which the puppy is being exported.
- 19. (1) A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the use of dogs for the meat trade without first satisfying the TCA Inc. that the purchaser is a member of an ANKC Ltd recognised canine controlling body in the overseas country.
  - (2) The member and purchaser shall further acknowledge in writing to the TCA Inc. that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.
- **20.** A member shall ensure that any person acquiring a dog from that member understands the requirements for the care, welfare and responsible ownership of the dog, and that the person acquiring the dog has the time and facilities (e.g. adequate fences, sufficient room and proper shelter) to fulfil their responsibilities.
- **21.** A breeder shall maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.
- **22.** (1) A member shall register all puppies bred (excluding those breeds listed in ANKC Ltd Regulation Part 6, Section 6.2 whose specific colours precludes them from being registered on any Register) by that member that are living at the date of registration.
  - (2) Such registration shall include all puppies from the litter on the one litter registration application form and shall be applied for within eighteen [18] months of the date of whelping.
- **23.** A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of
  - (a) the breed characteristics; and
  - (b) vaccination record or requirements; and

All exhibitions conducted by the Tasmanian Canine Association Inc and its affiliates are conducted under the rules and regulations of the Association, a copy of which may be inspected at the office of the event manager of the exhibition on the day of such exhibition.

The following rules/regulations apply to all exhibitions:

### **Financial Members:**

A person 18 years of age and over and who is a resident of Tasmania may not exhibit, handle, officiate in the judging ring or register an animal unless he/she is a current financial member of the TCA Inc. A person seven years and under the age of eighteen years who handles a dog in the judging ring is required to be a junior member of the TCA Inc or a member of an affiliated club. At least one parent or guardian is required to be a financial member of the TCA Inc.

Entry fees must be paid in accordance with Regulation 23.

### **Substitute Judges:**

The affiliate conducting an exhibition reserves the right to substitute judges if the committee deems it necessary. Entry fees are not refundable – refer TCA Inc Regulation 227.

It is the exhibitor's responsibility to have his/her exhibit/s available for judging in all classes or events for which it is correctly entered and for the classes for which it subsequently becomes eligible – TCA Inc Regulation 33 + 33A.

- (c) responsible dog ownership information; and
- (d) all documentation required by Dogs Tasmania.
- A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.
- **25.** (1) A member shall ensure that all dogs sold or disposed or by that member are in the best possible state of health.
  - (2) Where a dog with a health issue or disability is disposed of the member shall obtain from the recipient written and signed acknowledgement of the condition of the dog.
  - (3) A member shall take all reasonable action to reach agreement with a puppy purchaser if the puppy has health or behavioural problems that were not diagnosed prior to the sale of the puppy.
- **26.** A member shall not
  - (a) sell or dispose of a dog to a commercial pet wholesaler or retail pet shop unless they are accredited by the Pet Industry Association of Australia Limited (PIAA); or
  - (b) allow a dog owned by that member to be given as a prize or donation or to be auctioned.
- A member shall not conduct nor permit mother/son, father/daughter or brother/sister matings.

**NOTE:** The TCA Inc will not register the progeny of father/daughter, mother/son, brother/sister matings on the Main Register except where ANKC Ltd Regulations Part 6 Register and Registrations Section 8, Breeding applies.

- **28.** A member who provides or makes available a dog for use in a film, advertisement, promotion, or any media or public display shall ensure that
  - (a) the dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and
  - (b) the dog is presented in a manner that is unlikely to create a negative impression of dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.
- **29.** A member shall not include in false or misleading advertising relating to the conformation, characteristics or performance of that member's dog.
- 30. A member shall not misrepresent nor malign the conformation, characteristics or performance of another member's dog.

# Responding to Activists STEPS FOR HANDLING CONFRONTATION AT AN EXHIBITION OR EVENT

Proudly show our practices are best practice	Regardless of the risk of confrontation, every exhibitor should proudly uphold the standards expected of us as loving dog owners and members of Dogs Tasmania and present our dogs and ourselves positively.		
Advise the show or trial manager, call 000 if needed	Advise the event manager if you believe activists are present and they will advise the local police. If activists create a disruption or confrontation. call 000 immediately. If you call 000 clearly articulate the risk that the activists are posing: to yourself and others, the dogs' welfare, personal and venue property, etc.		
Do not engage	Do not engage directly. Keep calm even if provoked and keep your distance if possible.		
Ask them to leave	If activists enter the area you are using to house your dogs, speak with them politely to ask them to leave. Acknowledge their right to state their opinions in a lawful manner but ask that they respect your right to continue to look after your dogs' welfare in a safe manner without distress. Ask them to please leave the area and move to a space away from the dogs. They may not respond to the request, but it will make it clear they do not have permission to be there. Do not engage with them further.		
Move yourself and your dogs to a safer position	Your safety and welfare and that of your dogs comes first. If activists won't leave, relocate to an area that is safer for you and your dogs.		
Create a record	Video footage and photos taken on your phone of the above can be used by police. If there has been damage to property record the details and if possible wait until police have examined the scene before touching anything. Please always consider the safety of yourself and dogs when confronted with activists.


