# TCA PRESIDENT'S REPORT FOR ANNUAL GENERAL MEETING OF MEMBERS MONDAY 11 MARCH 2024

Well as they say time flies and here I am performing my last duty as President of Dogs Tasmania, chairing the Annual General Meeting of Members for 2024.

2023 has been a year of consolidation for DogsTas. There has been a number of notable achievements while at the same time there has been a further downturn in entries at Championship Shows.

We have now completed over two years in our new premises and it has proved ideal for our purposes. There is sufficient office space to comfortably accommodate our staff as well as the volunteers who assist. We have a meeting room which is proving very useful and which has now been set up to accommodate Zoom conference. In addition, the Library Custodians have laboured long and hard and during the year completed the task of cataloguing all the books and the Library is open most Tuesdays and in addition members can make appointments for other times if that doesn't suit.

By the end of the year, it was obvious that the indoor pavilion was close to being completed after many delays for a range of reasons. This means that there is now a dedicated show centre in both the north and south of the state. I know when the move to Pontville was mooted, there was a concern about the possible weather conditions. I think we have been very lucky that we did not have a really bad day during this period and now that the indoor pavilion is available hopefully, we will be protected from the elements and late finishes will have lighting available.

The Northern Committee has also been working hard and facilities at Quercus are being continually improved.

Our membership numbers have been very stable for the past ten years or so bucking the trend in other states. Unfortunately, our show entries have declined which means that clubs have had to use innovative methods to try and increase entries or reduce costs as it was getting to the stage it was very difficult to break even on shows. On the other hand, a number of new disciplines have been recognised in the past couple of years and are attracting new people to dog sports. It seems this will be the future of our hobby.

For other Controls another area of concern is the number of pedigree dogs which are making their way into dogs' homes. The rush to acquire a canine companion that occurred during COVID has come to a screaming halt and people are realising that keeping a dog when no one is home all day is not as simple as it sounds. Hopefully the reputable breeders will, no doubt, be assisting their puppy buyers to cope with this problem. Fortunately the Dogs' Home in Tasmania does not see many pedigree dogs and has agreed to contact the office when any come into their care.

Unfortunately, many people kept breeding until well after the boom finished and anecdotally there are many breeders who are having difficulty finding puppies their forever homes. This problem is Australia-wide and is making maintaining a balanced budget difficult.

The financial statement will show we have had another profitable but I caution that the profit is only roughly equal to our interest income and if rates start to fall again, we will have to carefully consider our budget.

Work has continued on the review of the Rules and Regulations. This is a very difficult and time-consuming exercise and is quite slow work. Hopefully a first draft will be with Council during 2024.

We have a number of new judges in a range of disciplines and we congratulate them all. New entries into the conformation training scheme are virtually non-existent and the Council will no doubt be looking at ways that this downward trend can be reversed.

The Animal Welfare Committee has advised that the regular review of the Act and Regulations and a discussion paper has been delayed pending the upcoming state election. I caution all members that it seems very likely that a hung parliament will be the result with the Greens likely holding the balance of power. They will use every tactic they can to impose further restrictions on domestic animal ownership and introduce draconian legislation similar to that introduced interstate. Unless we can show that we have good controls in place we could lose our status as approved an organisation. This means that we will have to demonstrate that we have started to monitor our members adherence to the Act. The necessary regulations are now in place and the Council will have to finalise how we will enforce these.

On the national scene, in 2022 Dogs Australia rebranded itself and has continued a publicity campaign to cement its place as Australia's principal canine organisation. To distinguish ourselves, Dogs Australia will continue to emphasize the quality of our breeders and the numerous measures that our breeders take to secure the health and welfare of the puppies they breed.

The first A2O Show in Tasmania was held and following changes to FCI Regulations there will be further changes to the CACIB Shows going forward. Now that the Junior and Veteran's titles have been introduced, Junior will no longer be eligible for a CACIB.

All of the ANKC Committees have a Tasmanian Representative and I would like to thank our highly qualified members who give up their valuable time to participate. I have been Treasurer of ANKC for many years and can report it is in a very sound financial position despite spending money to raise our profile.

Dogs Australia is looking to progress health testing in a number of areas and gradually this information is being transferred into the registration system and in many cases is being made mandatory for registration.

I have thanked a number of groups, in this report but in case I have missed anybody sincere thanks to all our volunteers. They give enormous amounts of their own time to enable our activities to continue. If we had to pay for the work they do, we would not have a sport.

In conclusion I would like to thank all Councillors for the work they too have put in during year and the great support they have given me. I would also pay special tribute to Past President Elaine Job who has assisted in the office every Monday for many years. Welcome too, to our new Councillor, Lani Smith.

It would also be remiss not to acknowledge the sterling efforts of Kerry, Judy and Debbie during 2023. The result is a credit to them. They all put in many hours carrying out duties which are not in their job description.

Finally, as this will be my last report as President of this Council, I would like to extend my thanks to all past Councillors that I have been fortunate enough to work with.

It has been an honour and pleasure to lead the team at DogsTas and as I still have a few more years to serve as a Councillor I will do my best to support those Councillors elected to the Executive in 2024 and subsequent years. I especially welcome Steve Eastley's appointment as President and as Vice President I will give him all the support I can.

## First Time Candidate Induction Course

**Applications close: 24 May 2024**

**To join the course you need to comply with the following requirements:-**

- 4.1 Aspiring Judge Entrance Program (1st Group or Single Breed)**
- 4.1.1** To enrol in the program as an Aspiring Judge, a member must fulfil the following criteria:
  - 4.1.1.1** Be 18 years of age or over;
  - 4.1.1.2** Have been a member of Dogs Tasmania for a minimum of eight (8) years during the ten (10) years immediately prior to the date of the application.
  - 4.1.1.3** Have bred at least three (3) litters under their own or shared Prefix.
  - 4.1.1.4** Have bred at least two (2) champions under their own or shared Prefix.
  - 4.1.1.5** The application shall be for the Group or Breed in which the requirements of 4.1.1.3 and 4.1.1.4 above have been met or partially met. **(Amended 10/12 – 7.4.1)**
  - 4.1.1.6** A Member must successfully complete training to become a Steward in the two (2) years prior to applying to become an Aspiring Judge and have Stewarded for a minimum of twenty (20) hours in the twelve months prior to making application.
  - 4.1.1.7** In the two years prior to enrolling, have successfully completed and have demonstrated a history of ongoing commitment to dog showing through the various aspect of the sport such as Show Management and other aspects of Affiliate and Show Administration. This commitment is to continue while ever a person is enrolled in the Judges Training Scheme.
  - 4.1.1.8** Complete and submit the approved enrolment form which must include evidence of the criteria of 4.1.1.1 – 4.1.1.7 above and be accompanied by the prescribed fee.

**LATE APPLICATIONS WILL NOT BE CONSIDERED**

Members are reminded of TCA Inc Regulation 94, hereunder stated:

**No person shall, at any sanctioned fixture or within the precincts of that sanctioned fixture, use any technique harshly or with undue harsh force to reprimand any dog. Undue force shall include the harsh use of slip-collar correction and the practice of ‘dominance down’ correction. The use of electronic or spiked/pronged collars is not permitted in accordance with the Animal Welfare Act.**

## **SUMMARY OF THE DOGS AUSTRALIA SPECIAL BOARD MEETING HELD VIA ZOOM VIDEO CONFERENCING 10 FEBRUARY 2024**

At the February 2024 Dogs Australia Special Board meeting, Directors resolved/considered the following:

**1. \* Dogs Australia Rules for the Conduct of SprintDog™**

It was RESOLVED that Dogs Australia approve the Rules for the Conduct of SprintDog™ Trials and the Dogs Australia SprintDog Qualifying Certificate to be effective from 1 July 2024.

**2. \* Dogs Australia Rules for the Conduct of Obedience Trials**

It was RESOLVED to rescind the October 2023 Board meeting decision to amend the Glossary in the Rules for the Conduct of Obedience Trials as follows:

Page 3 Fouling Present Rule:

A dog which fouls at any time while it is under the control of the judge must be disqualified

Change to:

A dog which fouls at any time while it is under the control of the judge must be disqualified and removed from the ring immediately.

Page 4 Disqualification

Present rule:

No points awarded. The dog is disqualified from all Trial Competition on the day and the judge must provide a written report to the Member Body within 14 days – the only exception being in the instances where the disqualification was incurred for continual barking, a correction penalty, fouling the ring or for handlers bringing training aids into the ring.

Change to:

No points awarded. The dog is disqualified from all Trial Competition on the day and the judge must provide a written report to the Member Body within 14 days. The only exception being In instances where the disqualification was incurred for continual barking, a correction penalty, fouling the ring or for handlers bringing training aids into the ring, handlers will only be disqualified from that class and no report is required.

Note: This rescission motion will be effective 1 July 2024.

It was RESOLVED for these amendments to be referred to the National Obedience & Tracking Committee for recommendation.

(h) Where an All Breeds Championship Show is not concluding at General Specials as defined in 7.1.7 all in Group awards are to be signified as Best in Group, Runner-up in Group and Classes in Group as offered.

7.1.6

(h) Where an All Breeds Championship Show is not concluding at General Specials as defined in 7.1.8 all in Group awards are to be signified as Best Neuter in Group, Runner-up Neuter in Group and Neuter Classes in Group as offered.

and Section 8 Alternative in-Group and in-Show Placing System be amended as follows:

8.3.7

General Specials is to be offered at all Alternative in-Group and in-Show Placing System Championship Shows

The following procedure is to be adhered to:

Where an affiliate is conducting more than one show on the same day and General Specials are not to be offered, it may only be at on the last show on that day.

Note: These amendments will be effective 1 April 2024.

**5. \* Dogs Australia Regulations Part 5 – Conformation Shows Clause 9.7.1 – Amendment**

It was RESOLVED that Regulations Part 5, Conformation Show Clause 9.7.1 be amended to read.

a. **Classes ineligible for the CACIB to be awarded:** (Amended 02/23, 5.11 – Effective 01/07/23)

Class 1 Baby Puppy For dogs aged three and under six months.

Class 2 Minor Puppy For dogs aged six and under nine months.

Class 3 Puppy For dogs aged six and under twelve months.

Class 12 Veteran For dogs aged eight years and over. (Added 02/23, 5.11 – Effective 01/07/23)

b. **Classes eligible for the CACIB:** (Amended 02/23, 5.11 – Effective 01/07/23)

Class 4 Junior For dogs aged nine and under eighteen months (providing the winner is over 15 months of age)



Class 5 Intermediate For dogs aged eighteen and under thirty-six months  
Class 11 Open For dogs 15 months and over that are not Champions  
Class 21 Champion To enter a dog in Champion Class, the title must have been confirmed by the issue of a Registered Pedigree Certificate with the title added by the day of the official closing date of entries.

Class 11 Open For dogs 15 months and over that are not Champions (Compulsory)  
Class 21 Champion (Compulsory) To enter a dog in Champion Class, the title must have been confirmed by the issue of a Registered Pedigree Certificate with the title added by the day of the official closing date of entries.

Note: These amendments will be effective 1 April 2024.

**6. \* Dogs Australia Regulations Part 5 – Conformation Shows Clause 9.7.1 – Amendment**

It was RESOLVED that Regulations Part 5, Conformation Show Clauses 9.5.5 and 9.5.6 be amended to read.

Existing

- 9.5.5 At all shows with few entries the organisers are permitted to have different groups judged together in the ring of honour for “Best in Group” competitions; however, this does not apply to World and Section Shows.
- 9.5.6 In accordance with the above provision, at FCI/CACIB Shows conducted in Australia the following combined groups may be utilised:
- Group 1 Sheepdogs and Cattle Dogs (except Swiss Cattle Dogs)
  - Group 2 Pinschers and Schnauzers – Molossoid Breeds – Swiss Mountain and Cattle Dogs
  - Group 3 Terrier Group
  - Combined Group 4 Dachshunds Group 6 Scenthounds and related breeds Group 10 Sighthounds
  - Group 5 Spitz and Primitive Types
  - Combined Group 7 Pointing dogs Group 8 Retrievers – Flushing dogs – Water dogs
  - Group 9 Companion and Toy dogs

Amended. (WEF) 01 July 2024

- 9.5.5 At all FCI-CACIB shows, for the “Best in Group” final competitions, the ten FCI groups must be judged separately in the main ring.
- 9.5.6 Reserved

## **BUSINESS ARISING FROM THE MINUTES:**

### **AWAC – Kennel Visits**

### **Australian Flyball Association**

D. Strong advised the meeting that the AFA had been unsuccessful in obtaining insurance for its affiliates clubs' Flyball Trials.

The EO agreed to look into cover with the Association's Public Liability Insurance policy.

### **Ramps**

S. Eastley advised the meeting that the black surface on the ramps can become hot during the day and that folding the ramp section over the table surface solved the problem.

## SHOW AND TRIAL REGULATIONS

All exhibitions conducted by the Tasmanian Canine Association Inc and its affiliates are conducted under the rules and regulations of the Association, a copy of which may be inspected at the office of the event manager of the exhibition on the day of such exhibition.

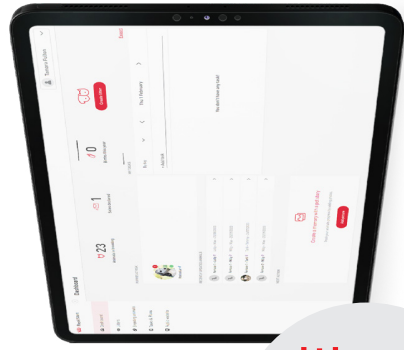
