Welcome to the New Year. I hope everyone enjoyed the Festive Season.

A lovely turn out for the Christmas Show at Pontville to finish last year's Conformation season. Thank you to everyone for their assistance with a huge vote of thanks to Kerry and Judy for making the day a resounding success.

The discussion paper from the Department of Natural Resources & Environment has now closed following an extension for submissions until 17 January 2025. David Sales, Kerry Smith and myself met with the Hon Jane Howlett MP and two members of her staff to discuss proposed changes to the current regulations. Discussions revolved around Dogs Tasmania maintaining its current exemption. We were advised that we would have further opportunities to meet with department staff once public consultation has closed and information derived is put into draft policies.

An important reminder to club executives: Club Annual Returns are now overdue, with several clubs yet to submit and others only having submitted partial returns. If you are unsure of your club's status or if you need assistance in complying please contact the office ASAP.

Breeders are reminded that it is a Dogs Tasmania requirement that pedigrees be provided with puppies within twenty-eight (28) days of sale, or the issue date of the registration certificate, whichever date occurs first. Recent complaints to the office have illustrated that not all are complying.

The Annual General Meeting of Dogs Tasmania will this year be held in the south of the state, on Monday 10 March 2025 commencing at 11.00am at the Civic Centre, 25 Greenpoint Road, Bridgewater. A Notice of Motion is included in this Gazette.

ANKC AGILITY/JUMPING RULE REVIEW

A Zoom meeting to discuss the submissions put forward by Member Bodies will be held Tuesday 18 February 2025 commencing at 7.00pm. Members wishing to participate in this meeting should advise this office to enable us to send you the Zoom link.

Members' attention is drawn to TCA Inc Regulations 28, hereunder stated:

Any dog entered or exhibited by an un-financial member of the TCA Inc may forfeit any award/s gained and/or the exhibitor/handler may incur such fine as decided by the Council of the TCA Inc.

NOTICE OF MOTION – AGM

Submitted by Cheryl Houghton

Clause 8.1 of the Constitution be amended by the deletion of Clause 8.1.3 and Sub-clauses 8.1.3.1, 8.1.3.2 and 8.1.3.3.

Clauses 8.1.1 and 8.1.2 to remain unaltered.

8.1 *No person shall be eligible for election or appointment, or be elected or appointed pursuant to this Clause, unless the person at the time of closing of nominations:*

8.1.1 *Is an ordinary, secondary, pensioner or life member of the TCA and at least eighteen (18) years of age.*

8.1.2 *Has been a member of the TCA, or an ANKC affiliated body, for a total of at least five (5) years up to and including the closing date for nominations.*

8.1.3 *Has served as a member of the Council or the Council of an ANKC affiliated body;*

OR

~~**8.1.3.1** *has held an executive position on a body affiliated with the TCA for a period or periods in total of not less than two (2) years;*~~

OR

~~**8.1.3.2** *has held an executive position on a body affiliated with a member body of the ANKC for a period or periods in total of not less than two (2) years;*~~

OR

~~**8.1.3.3** *has held an executive position on the committee of a body incorporated under the Act for a period or periods in total of not less than two (2) years; in addition to having held an executive position on a body affiliated with the TCA or with a body affiliated with a member body of the ANKC, for a period or periods in total of not less than one (1) year.*~~

Rationale

There is no doubt there is some dissatisfaction on many levels within our hobby and it has become quite clear that some changes are necessary.

With very few Club Executive positions available, some having held positions for a long time and with no plans to give them up in the foreseeable future, there is little opportunity for those who wish to obtain the qualifications currently required in Clause 8.1.3. The result is a limited pool of members qualified to nominate, the flow on being members unable to choose their preferred representation on Council.

The last time the membership was offered a choice was in 2019 (nominations in 2018) when five nominated and prior to that, six in 2018. In 2021 there were only two valid nominations for the four vacancies the following year resulting in the need for a by-election and that too received just two nominations. The previous year, due to a resignation, there were five vacancies but only four nominations. On that occasion the fifth was filled by Council. And this year the valid nominations once again equaled the number of vacancies.

There are quite possibly members available who, from experience, have quite a lot to offer and are prepared to nominate but are unable due to this almost impossible to fulfil requirement.

My research failed to locate *all* requirements from each state but based upon that which I did find it appears that Tasmania is possibly the only state that requires such a qualification. For most it appears that a nominee must simply be over the age of 18 and a financial member, in some cases for two, four or five years.

In conclusion, whilst impossible to predict with any certainty whether such change to the Constitution would encourage more to nominate for a position on Council, it would most definitely increase the qualified membership pool thus providing opportunity.

Members contacting Dogs Australia Directly

Recent discussions regarding members contacting Dogs Australia directly, have highlighted the fact that some members may not be aware of the history and Constitution of ANKC Ltd. An explanation of its relationship with the State and Territory Member Bodies can be found in the “About Us” section on the Dogs Australia website and in the Constitution. We hope the following extracts from them will help members understand why any matters concerning Dogs Australia must be referred to their Member Body.

History

When the original Constitution was drafted in 1958, a vital resolution was, “*That the Australian National Kennel Council be constituted so that it is empowered to act only as a co-ordinating and recommendatory body*”. Over the succeeding years the Australian National Kennel Council gradually moved in character from an “advisory” towards a “co-ordinating” body, many changes were made to rules and procedures. In 1982 a new Constitution was adopted which designated ANKC as a Co-ordinating Body. This change of Constitution enabled many decisions to be made which would previously have been rejected. It also led to wide discussion on various issues and areas where ANKC might take control or take over the improvement of certain activities.

The following extract from our **Mission Statement** reinforces that position:

“To act as spokesperson on all canine related activities on a national basis on behalf of State Member Bodies and to pledge assistance and support to the respective State Member Bodies”.

There are 33 Objects listed in the Constitution; the following illustrate the ANKC role as a Co-ordinating Body

- d) *To act as a federal organisation representing the interests of its Member Bodies in each of the States and Territories of the Commonwealth of Australia.*
- f) *To promote uniformity in regard to laws and regulations affecting Dog owners and breeders throughout the Commonwealth of Australia.*
- g) *To enable its Member Bodies to take co-operative action on matters which are of common interest and are for their mutual benefit in the promotion of canine affairs.*

A very important item in the Constitution is Clause 4. Interference with Powers

This is a long clause but it is very instructive and recommended reading.

4. *Except where expressly provided in this Constitution, the ANKC shall not interfere with the exercise of the powers or responsibilities of a Member Body, without the express written authority of such Member Body. The ANKC recognises that Member Bodies have the following exclusive powers in relation to themselves and their activities respectively:*

Logistically

There are currently just over 29,000 members of Dogs Australia Member Bodies, the Dogs Australia office staff consists of the Administrator and a part-time Assistant. The Dogs Australia Directors are appointed by the Boards of their Member Bodies, they have in turn been elected by the members, they are the go to for Dogs Australia issues.

All exhibitions conducted by the Tasmanian Canine Association Inc and its affiliates are conducted under the rules and regulations of the Association, a copy of which may be inspected at the office of the event manager of the exhibition on the day of such exhibition.

The following rules/regulations apply to all exhibitions:

Financial Members:

A person 18 years of age and over and who is a resident of Tasmania may not exhibit, handle, officiate in the judging ring or register an animal unless he/she is a current financial member of the TCA Inc. A person seven years and under the age of eighteen years who handles a dog in the judging ring is required to be a junior member of the TCA Inc or a member of an affiliated club. At least one parent or guardian is required to be a financial member of the TCA Inc.

Entry fees must be paid in accordance with Regulation 23.

Substitute Judges:

The affiliate conducting an exhibition reserves the right to substitute judges if the committee deems it necessary. Entry fees are not refundable – refer TCA Inc Regulation 227.

It is the exhibitor's responsibility to have his/her exhibit/s available for judging in all classes or events for which it is correctly entered and for the classes for which it subsequently becomes eligible – TCA Inc Regulation 33 + 33A.
