Lacey and I (Tamika Cassidy) began training at the Hobart Dog Training Club in 2019 and competed in our first Novice Jumping trial in 2020. Over the years, we have built a partnership founded on trust, commitment, and teamwork.

Some of our fondest memories and achievements include competing at the 2024 Agility Nationals in NSW and being awarded Hobart Dog Training Club's Senior Agility Dog of the Year in 2024. In 2026, at 9 years of age, Lacey achieved her Jumping Championship title, a milestone that reflects years of dedication, perseverance, and countless hours spent training together.

This title represents not only success in the ring, but also the trust, commitment, and partnership we have built over many years. I couldn't be prouder of everything we have achieved together.

RILEYO ADX GD SDX JDO JDM5 (Riley) – pictured right

Riley was a COVID dog, adopted at 10 months in 2020. Over-exuberant and a jumping escape artist, her energy and intelligence seemed a perfect fit for agility. We started training at Hobart Dog Training Club in 2021 and began competing in October 2022. By the end of 2022, Riley had her JD Title and was named HDTC's Junior Agility Dog of the Year; after accumulating many more titles, she was awarded HDTC's Senior Agility Dog of the Year in 2025.

My (Lee Astheimer) learning curve has been much steeper than Riley's, but this fantastic sport has created a unique and powerful bond between us that extends into everything we do. Riley's award of Jumping Champion this year is a wonderful recognition of our teamwork and love of this sport.

SHOW CERTIFICATES

At the Conformation Club Executive meeting the printing and distribution of certificates was discussed at length.

The difficulty in providing additional manpower and the increased additional costs in reference to running the office for clubs was highlighted by many of the clubs.

With the introduction of iPads and the continual improvements to the ShowManager system by Ruth and Jeremy Cook, it was decided to end the printing of certificates at shows. This will be phased out by 1 January 2027 or once the current stocks of certificates has been exhausted.

Certificates will be e-mailed out after the show has finished or you will be able to print your certificates at home via the ShowManager website – in the “My Dog” section, click on the dog in question’s profile, at the top you will see “certificates”. Next to the applicable show you can click certificate and print. This will make a big difference for clubs and will mean exhibitors are not kept waiting at the end of the day.

Responding to Activists

STEPS FOR HANDLING CONFRONTATION AT AN EXHIBITION OR EVENT

Proudly show our practices are best practice	Regardless of the risk of confrontation, every exhibitor should proudly uphold the standards expected of us as loving dog owners and members of Dogs Tasmania and present our dogs and ourselves positively.
Advise the show or trial manager, call 000 if needed	Advise the event manager if you believe activists are present and they will advise the local police. If activists create a disruption or confrontation. call 000 immediately. If you call 000 clearly articulate the risk that the activists are posing: to yourself and others, the dogs' welfare, personal and venue property, etc.
Do not engage	Do not engage directly. Keep calm even if provoked and keep your distance if possible.
Ask them to leave	If activists enter the area you are using to house your dogs, speak with them politely to ask them to leave. Acknowledge their right to state their opinions in a lawful manner but ask that they respect your right to continue to look after your dogs' welfare in a safe manner without distress. Ask them to please leave the area and move to a space away from the dogs. They may not respond to the request, but it will make it clear they do not have permission to be there. Do not engage with them further.
Move yourself and your dogs to a safer position	Your safety and welfare and that of your dogs comes first. If activists won't leave, relocate to an area that is safer for you and your dogs.
Create a record	Video footage and photos taken on your phone of the above can be used by police. If there has been damage to property record the details and if possible wait until police have examined the scene before touching anything. Please always consider the safety of yourself and dogs when confronted with activists.

RETRIEVING & FIELD TRIAL

“HALL OF FAME”

2026 Nominations

In the first twenty-three years of elections, Dogs Australia has received nominations for 61 dogs and 49 people to be considered for induction into the Retrieving & Field Trial Hall of Fame. From the nominations received 39 outstanding dogs and 31 exceptional people have been inducted.

The criteria for the two categories for selection are the following:

1. **Outstanding Gundogs** (must be permanently retired from further competition and have not competed for the past 12 months, or be deceased):
 - (a) Their record as a winning dog i.e., CLUB – STAKE – DATE – JUDGE – PLACE and/or
 - (b) Their production record.
 - (c) The eligibility for a dog should be based on its entire competitive career and previous record as a producer, not merely for a particular win or for a heroic deed within the field and retrieving trial sphere.
 - (d) Subject to the receipt of a formal application, dogs that have been awarded the title of Grand Champion and have gained a total number of points equal to, or greater than, twice the total number required for that award, shall automatically be inducted into the Hall of Fame. Such applications must include full particulars and a brief resume of the dog's career.
 - (e) Subject to the receipt of a formal application, dogs winning at least two National Championships in the same discipline shall automatically be inducted into the Hall of Fame. Such applications must include full particulars and a brief resume of the dog's career.
2. **Prominent Persons**
Their record of a broad combination of accomplishments as:
 - (a) Club Official
 - (b) Judge
 - (c) Owner
 - (d) Handler

The distinction of nomination should be accorded to those who have made outstanding contributions to the field or retrieving game. Nominees should be **givers** to the sport and not **takers**.

Nominations are now being called for the current year. In addition to applications submitted in relation to Outstanding Gundogs 1 (d) and 1 (e), a maximum of two other outstanding gundogs and two prominent persons may be elected each year.

Nomination:

1. Clubs or members may nominate DOGS and PEOPLE considered worthy of awards, including full details of accomplishments within the above categories and with verification. In the case of dogs, nominations should include the full name, title, owner and date of birth.
(Please note it is a condition of nomination that the nominator/s provides accurate written material supporting the nomination. In the absence of such accurate supporting material, or should the supporting material later prove to be inaccurate in areas of significance, the Selection Panel for the Dogs Australia Retrieving & Field Trial Hall of Fame reserves the right to reconsider its decision and if appropriate, delete the name of the Prominent Person or Distinguished Dog from the list of inductees.)
2. **Nominations shall close on 30 October, 2026** at respective Member Body offices for forwarding to Dogs Australia.

SUMMARY OF THE DOGS AUSTRALIA SPECIAL BOARD MEETING HELD VIA ZOOM ON 20 JUNE 2026

At the June 2026 Dogs Australia Special Board meeting, Directors resolved/considered the following:

1. Conformation Judges Training

It was RESOLVED that the Conformation National Judges Training committee meet in person over a weekend in South Australia before the end of August 2026 to decide on a compulsory National Conformation Judges training scheme for all member bodies to adhere to and present to the October meeting.

A person seven years and under the age of eighteen years who handles a dog in the judging ring is required to be a junior member of the TCA Inc or a member of an affiliated club. At least one parent or guardian is required to be a financial member of the TCA Inc.

Entry fees must be paid in accordance with Regulation 23.

Substitute Judges:

The affiliate conducting an exhibition reserves the right to substitute judges if the committee deems it necessary. Entry fees are not refundable – refer TCA Inc Regulation 227.

It is the exhibitor's responsibility to have his/her exhibit/s available for judging in all classes or events for which it is correctly entered and for the classes for which it subsequently becomes eligible – TCA Inc Regulation 33 + 33A.
